# RENEWAL OF AN INDEPENDENT CONTRACTOR AGREEMENT BETWEEN THE VILLAGE OF OAK PARK AND ALLIED GARAGE DOOR, INC. TO PROVIDE EMERGENCY REPAIRS AND MAINTENANCE SERVICES ON OVERHEAD DOORS AT VILLAGE OWNED BUILDINGS IN AN AMOUNT NOT TO EXCEED \$35,000.00 IN FISCAL YEAR 2022.

THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and Allied Garage Door, Inc. an Illinois corporation (hereinafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

### **RECITALS**

**WHEREAS,** the Parties previously entered into an Independent Contractor Agreement dated February 9, 2021 ("Agreement"); and

**WHEREAS,** the Parties seek to renew the Independent Contractor Agreement pursuant to the terms of the Agreement in an amount not to exceed \$35,000.00 in 2022.

**NOW, THEREFORE,** in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **RENEWAL OF AGREEMENT.** The Independent Contractor Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement from the Effect Date of this Renewal through December 31, 2022.

3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Independent Contractor Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Renewal shall be effective on the date of its execution by the Interim Village Manager of the Village Oak Park.
