## ARE YOU ELIGIBLE?

Customers must meet our eligibility criteria to purchase technology from PCs for People.  
Read below to find out if you are eligible.

### Eligibility

PCs for People requires photo identification and income documentation for program qualification. Acceptable documents for income documentation fall into two categories: 1) Proof of current enrollment in an income-based government assistance program OR 2) Documentation from a government source of current income under 200% of the federal poverty level (relative to household size). Please note we do not check citizenship or immigration status.

#### Acceptable Forms of Photo Identification

- Driver's license or state ID card for non-drivers
- Passport
- Formal ID card (such as veteran or student)
- Company or work-issued identification

### Qualifying Income-Based Assistance Programs

Documents must be dated within the last year and/or show current coverage at the date of submission.

- Adult & Child Mental Health Case Management\*
- Employment Services (only if income-based in your state)
- Extended Foster Care
- Food Support (a dated letter showing current eligibility is required)

## Qualifying Income Documentation

For households that qualify under the net income test (200% federal poverty level- FPL) the following documentation will be acceptable as part of the application process. Annual benefits must meet the FPL guidelines (See table below) :\*

- The prior year's state, federal, or tribal tax return (W2 forms or pay stubs are not acceptable)
- A Social Security statement of benefits\*
- A Veteran Administration statement of benefits\* (VA cards alone are not accepted)
- A retirement/pension statement of benefits\*
- An Unemployment/Workmen's Compensation statement of benefits\*
- Federal or tribal notice letter of participation in General Assistance\*

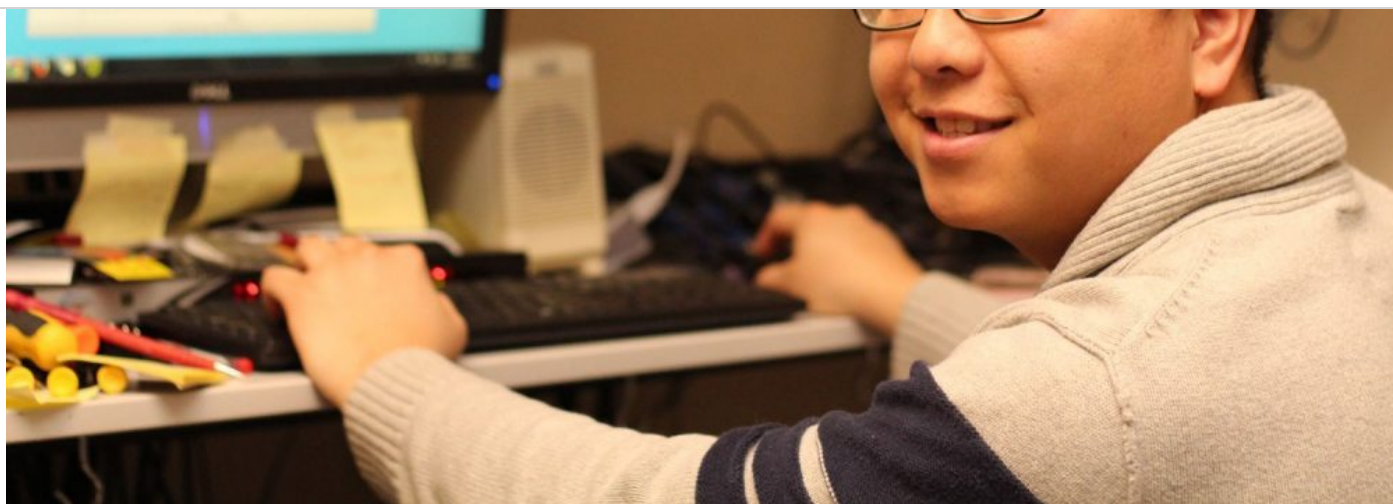

## Eligibility NOT accepted:

- Hand-written documents
- Tax returns where the applicant is claimed as a dependent
- Medicare
- W-2 forms or Pay Stubs
- Bank statements with deposit records
- EBT app screenshots
- Notices to reapply for a benefit

\*Any proof of eligibility is subject to approval by PCs for People staff. Additional documents may be required to unquestioningly prove income or enrollment in a government assistance program.
