**Industry Braces for a Challenging Season**

Small businesses across the nation are experiencing the uncertainty of the economy due to ongoing supply chain

challenges and a surge in inflation. From consumer product retailers, to manufacturers, to fireworks display companies and live special effects entertainment, our various industry segments have all been impacted.

In October 2021, the Consumer Price Index, which tracks the prices consumers pay for goods and services, rose by the highest amount since 1990. Other measures of inflation show prices rising at the highest rate in 13 years. In a fourth quarter survey conducted by CNBC, 74% of small business owners said that were experiencing rising costs of supplies and 47% of those businesses were passing those costs on to their customers with another 32% indicating that they will have to raise prices soon if inflation persists.

While the fireworks industry proved to be recession resistant in the late 2000's, will the industry be able to weather the supply chain disruptions and surge in inflation?

Some of the areas where inflation has hit the fireworks industry include:

- The rising cost of supplies and raw materials has risen conservatively at approximately 20%, increasing the cost of producing safe, high-quality pyrotechnic products.
- Shipping costs have risen dramatically since 2019 from \$8,000-10,000 per shipping container to approximately \$45,000 per container which impacts the overall cost of the product by roughly 50%.
- Insurance has significantly increased during the past year including product liability, auto, truck, and hazardous materials insurance.
- Transportation costs have dramatically increased as well. Gas prices are the highest since 2015, almost doubling from just over a year ago for diesel fuel. This especially impacts truckers transporting containers from ports to warehouses as well as affecting the very high cost of tugboat fees for moving barges which consume 100-200 gallons per hour inside ports and up to 500 gallons consumed per hour when pushing a barge against a current.
- Operational costs, including labor, have increased as well.
- Domestic shipping/rental rates have skyrocketed. Truck and auto rental prices have nearly doubled from just a year ago, due to limited supply combined with high demand, especially in the early summer. Due to the supply chain crisis, the fireworks industry is competing with corporations like FedEx and Amazon to meet the high seasonal demands associated with Independence Day and other summer festivals, with limited rental companies and an increased demand. Just like empty car dealership lots due to lack of computer chips, truck rental companies also are dealing with a 4 to 6 month backlog waiting for cargo boxes to be mounted on truck chassis.

The entire fireworks industry is faced with these challenges and overall costs are up 35%+ across the fireworks industry.

As the industry prepares for unprecedented demand and a post-pandemic full recovery in Independence Day celebrations, will it

be able to weather the ongoing supply chain crisis and the economic impact of rising costs and inflation?

## **APA Std. 87-1 Revision Process**

The 2018 APA Standards 87-1A, B, and C are currently being reviewed by APA's Standards Committee and they have begun a formal revision process. The 2018 Standards became effective in 2020 and now manufacturers and industry members have had an opportunity to utilize the new Standards and discover errors or omissions as well the need to address new products and chemicals.

By this notice, APA is seeking comments and suggested revisions to the APA Standards by members of the industry and general public. ## **APA Seeks Renewal of HOS & ELD Exemption**

On March 30, 2022, APA formally filed a request with the Federal Motor Carrier Safety Administration (FMCSA) to renew its exemptions for fireworks display carriers from the 14-hour Hours of Service (HOS) and the Electronic Logging Device (ELD) rule during the 11-day period surrounding the Independence Day holiday. In 2021, the exemptions were renewed for only a one-year period and the Agency then conducted a safety audit on 58 of 60 APA member company exemption participants.

In our request for a 5-year renewal of the exemptions, APA emphasized that the results of the safety audit presented to us during the Winter Education Conference were extremely skewed because the 2021 Independence Day holiday was not representative of the volume of community celebrations typically performed by the industry. Last year, only 60% of the nation's community Fourth of July celebrations resumed and most of the large community displays did not take place. APA further emphasized that the random selection of driver files requested during the audit did not focus on the drivers who actually operated under the exemptions. Accordingly, the audit sampling did not accurately reflect the utilization of the exemptions by our industry members.

We are hopeful that the Agency will issue the HOS & ELD exemptions for a 5-year period. However, participants need to keep in mind that the exemption notice is typically published right upon the cusp of its effective date, June 28. We will keep participants apprised of the status of the exemption.

## **OSHA Issues Guidance for Heat-Related Hazards**

The Occupational Safety & Health Administration (OSHA) has issued an Agency memorandum establishing an enforcement initiative to prevent and protect employees from serious heat-related illnesses and deaths while working in hazardous hot indoor or outdoor environments. We encourage APA members to review the enforcement memorandum and OSHA presentation. OSHA is currently working on an advanced

rulemaking and the enforcement initiative is most likely intended to support the need for that rulemaking. We extend our thanks to APA Director Ken Sprague for sharing these OSHA documents with us.

## **Shanghai Port Operational Status**

Shanghai is once again under restrictions due to a surge in Covid-19 cases. Naturally, fireworks importers are anxious about what these restrictions mean and how will they impact the already disrupted supply chain. Danny Zhou, Shanghai Huayang International Logistics, provides the following update:

Shanghai Port is only affected by road transport. Truck drivers must enter the port with a 48-hour nucleic acid negative certificate. Shanghai port encourages customers to adopt barge and rail transport modes to ensure normal shipment of goods. Per Port news, Shanghai Port immediately launched services such as "Container Land Water Conversion" and "Sea Rail Intermodal Transport", which alleviated the pressure on the shortage of road transport resources in the port by optimizing the transportation system.

All fireworks containers are moved from inland Shanghai by barge (through the Yangtze River Waterway) – this is the current logistics scheme recommended and ensured by the Shanghai government and Port Group. Additionally, shipping companies have made corresponding adjustments. After modifying operations several times previously during the pandemic this approach has proven to be efficient. All operations are currently normal (from booking to shipping) and there is no impact on the shipment of goods (especially fireworks). The volume or throughput at the Port of Shanghai remains high. We will keep the industry updated on the situation at Shanghai Port.

## **Important Notice for Consumer Fireworks Companies**

Consumer fireworks in commerce are subject to all of the regulatory requirements in the Hazardous Materials Regulations (HMR) 49 CFR Parts 171-180. The HMR apply to the commercial transportation of consumer fireworks, including transportation conducted by wholesale customers and non-profit organizations that pick-up consumer fireworks from a distribution facility or retail outlet. Purchases by individual customers for personal use are not considered to be in commerce and are excluded.

We encourage all consumer fireworks companies to review the guidance documents prepared by PHMSA in advance of your peak season activities. It is critical for companies to understand the HMR and how the requirements apply to shipments that you offer at your distribution and wholesale facilities where the customer picking up that shipment must also meet requirements of the HMR. Depending on the size of the shipment / order, additional requirements apply when the shipment is over 1,000 pounds gross weight on a vehicle, including additional driver, placarding, security plan, and hazmat registration requirements. ### AGREEMENT

This contract entered into this 18th day of APRIL, 2022 by and between Mad Bomber Fireworks Productions of Kingsbury, Indiana hereinafter to as Seller, and VILLAGE OF OAK PARK 123 Madison Street Oak Park, IL 60302  
Herein after referred to as Buyer, of: VILLAGE OF OAK PARK State Illinois 60302

Witness: Seller agrees to provide and Buyer agrees to purchase certain Fireworks Display in accordance with the Program. Buyer will pay Seller a sum of \$35,000 for said Display. Upon acceptance of this agreement Buyer will not pay Seller a sum of (waived) as an Earnest Money Deposit with the Balance due and payable within 30 days after the display date agreed upon. A late charge of 1½% per month will be assessed on accounts not paid within thirty days of display date. Buyer agrees to pay any and all collection costs, including reasonable attorney's fees and court cost incurred by Seller in the collection or attempted collection of any amount due under this agreement and invoice.

Both Seller and Buyer mutually agree to the following terms, conditions, and stipulations:

1. Seller will present said Fireworks Display on the evening of the 4th day of JULY, 2022, it being understood that should there be inclement weather the day of the display the Seller has sole discretion to cancel display. An alternate display date will be given within six months of the original Display Date agreeable to both the Seller and Buyer.
2. The Fee for cancellation for any reason of the Fireworks Display is 40% of the agreement price if Buyer chooses to not select another Display Date within six months of the original Display Date.
3. Buyer will provide a sufficient area for the Display, including a minimum spectator set back of 280' feet at all points from the discharge area. Buyer will provide protection of the display by roping-off or other suitable means. Buyer will provide adequate police protection to prevent spectators from entering display area. Buyer agrees to search the fallout area at first light following a night display.
4. Seller reserves the right to terminate the Display in the event that persons enter the secured Danger Zone and Security is unable to secure the Danger Zone.
5. Seller agrees to provide Qualified Technicians to take charge of and present said Display.
6. Seller agrees to provide Liability Insurance in the amount of \$10,000,000.00 for the benefit of both the Buyer and Seller. All individual entities listed on the Certificate of Insurance will be deemed and additional insured per this contract..
7. Mad Bomber Firework Productions retains the right to substitute product of equal or greater value in the event of shortage. or unavailability of any particular item on the proposal.
8. Seller and Buyer agree to include Attachments, if any. See Attachments Electronically Fired Sow \_\_\_\_\_
