

**RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE VILLAGE OF OAK PARK
AND ALARM DETECTION SYSTEMS, INC. FOR BURGLAR AND FIRE ALARM SYSTEM
MONITORING AND MAINTENANCE FOR VILLAGE-OWNED BUILDINGS FOR A
SEVEN-MONTH PERIOD IN AN AMOUNT NOT TO EXCEED \$17,304.36**

THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT (hereinafter referred to as the “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and Alarm Detection Systems, Inc. (hereinafter referred to as the “Contractor”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated May 3, 2019 (“Agreement”); and

WHEREAS, the Parties seek to renew the Professional Services Agreement for a seven-month period pursuant to the terms of the Agreement in an amount not to exceed \$17,304.36.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Professional Services Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement from the effective date of this Renewal and ending on December 31, 2022.
3. **OTHER PROVISIONS OF THE CONTRACT TO REMAIN IN EFFECT.** All other terms and conditions of the Professional Services Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the date of its execution by the Village Manager of the Village Oak Park.
