## AN AMENDMENT TO A PROFESSIONAL SERVICES AGREEMENT WITH ADVANCED SECURITY SOLUTIONS INC. FOR SECURITY SERVICES AT VILLAGE PARKING STRUCTURES AND VILLAGE HALL TO RENEW THE TERM OF THE AGREEMENT THROUGH OCTOBER 31, 2022 AND TO CHANGE THE NOT TO EXCEED AMOUNT FOR THE RENEWAL TERM FOR SERVICES AT VILLAGE PARKING STRUCTURES TO \$236,000.00 AND FOR SERVICES AT VILLAGE HALL TO \$19,000.00

THIS AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT between the Village of Oak Park, an Illinois home rule municipal corporation, and Advanced Security Solutions Inc, an Illinois corporation, is entered into this \_\_\_\_ day of August 2022 (collectively referred to as the "Parties").

## **RECITALS**

WHEREAS, the Parties entered into an Independent Contractor Agreement dated July 28, 2020 ("Agreement"); and

WHEREAS, the Parties renewed the Agreement on July 19, 2021 for a one (1) year term; and

WHEREAS, the Parties seek to amend Section 3 of the Agreement pursuant to this Amendment to reflect new total not to exceed amounts for the renewal term for services at Village parking structures and for services at Village Hall; and

**WHEREAS,** the Parties seek to amend Section 3 of the Agreement pursuant to this Amendment to specify new hourly billable rates; and

**WHEREAS,** the Parties seek to amend Section 4 of the Agreement pursuant to this Amendment to reflect the new renewal term through October 31, 2022.

**NOW, THEREFORE,** in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
- 2. **AMENDMENT TO AGREEMENT.** Section 3.1 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

The Village shall compensate the Contractor for the Services in an amount not to exceed \$587,274.24 \$255,000.00 ("Contract Price"), which includes \$557,274.24 \$236,000.00 for services at Village parking structures and \$30,000 \$19,000.00 for security services at Village Hall, on annual basis for the initial term of this Agreement. The hourly billable rates will be as follows: Security Officer = \$32.00 per hour, Supervisor = \$35.00 per hour and Vehicle = \$6.00 per hour. The

Contractor shall be paid installments not more frequently than once each month ("Progress Payments"). Payments shall be made within thirty (30) days of receipt by the Village of a pay request/invoice from the Contractor. Payments shall be due and owing by the Village in accordance with the terms and provisions of the Local Government Prompt Payment Act, 50 ILCS 505/1 et seq., except as set forth herein.

3. **AMENDMENT TO AGREEMENT.** Section 4.1 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

This Agreement shall take effect upon the Effective Date as defined herein and shall expire on the one year anniversary of the Effective Date at 11:59 a.m. This Agreement shall take effect on August 1, 2022 at 12:00 a.m. Central Time and shall expire on October 31, 2022 at 11:59 p.m. Central Time.

- 4. **AMENDMENT TO AGREEMENT.** Section 4.2 of the Agreement is deleted in its entirety.
- 5. **OTHER PROVISIONS OF THE CONTRACT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
- 6. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
