June 3, 2022 The Police Department's Response to a Village Board Question:

The final analysis concluded that of the 16 violent offenses, 12 occurred between the hours of 10pm and 6am. 4 of the 12 violent offenses involved the discharge of a firearm (shooting) and one unlawful possession of a firearm.

Of the eight 24-hour gas stations, the four listed below have the most concentrated violent offenses occurring after 10pm. The offenses are averaging approximate one to two incidents per year, with the exception of the BP Gas Station at 520 Austin Blvd. The BP Gas Station located at 100 Chicago Ave has the most violent offenses involving the discharge of firearms. All offenses involving the discharge of a firearm are **bolded**.

The police department does not support reducing the hours of the 24-hour gas station due to the above findings in addition to the reasons detailed in Director Grossman's memo. The police department proposes other proactive options directed specifically to the businesses with the most violent offenses: 6129 North Ave, 100 Chicago Ave and 520 S. Austin Blvd.
