

**AMENDMENT TO A SUBRECIPIENT GRANT AGREEMENT BETWEEN UNITED CEREBRAL PALSY
SEGUIN OF GREATER CHICAGO TO ADD ADDITIONAL SERVICES**

THIS AMENDMENT TO THE SUBRECIPIENT GRANT AGREEMENT (hereinafter referred to as the “Amendment”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and United Cerebral Palsy Seguin of Greater Chicago, an Illinois not-for-profit corporation (hereinafter referred to as the “Subrecipient”) is entered into as of the effective date set forth below (also collectively referred to as the “Parties”).

RECITALS

WHEREAS, the Parties previously entered into a Subrecipient Grant Agreement dated September 21, 2021 (“Agreement”); and

WHEREAS, the Parties seek to amend the Agreement to add additional services as set forth herein.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 (“Scope of Services”) of the Agreement is amended to add the underlined language as follows:

A. Subrecipient’s project schedule and project budget (collectively referred to as “the Project”) are set forth in the Subrecipient’s Program Year 2021 Community Development Block Grant Program Proposal, attached hereto and incorporated herein by reference as Exhibit A (hereinafter the “Subrecipient’s Proposal”) and Subrecipient’s correspondence dated July 25, 2022, attached hereto and incorporated herein by reference.

3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment shall be the last date of its execution by one of the Parties as reflected below.
