

**AN AMENDMENT TO AN INDEPENDENT CONTRACTOR AGREEMENT WITH REVCON
TECHNOLOGY GROUP, INC, FOR THE SERVICE AND MAINTENANCE OF PARKING ACCESS AND
REVENUE CONTROL SYSTEMS AT THE VILLAGE'S HOLLEY COURT AND AVENUE PARKING
GARAGES FOR FISCAL YEAR 2022 TO CHANGE THE NOT TO EXCEED AMOUNT FROM
\$86,300 TO \$96,800.00 AND AUTHORIZING ITS EXECUTION**

THIS AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT between the Village of Oak Park, an Illinois home rule municipal corporation, and Revcon Technology Group, Inc, an Illinois corporation, is entered into this ____ day of December 2022 (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into an Independent Contractor Agreement dated December 9, 2020 ("Agreement"); and

WHEREAS, the Parties renewed the Agreement on December 6, 2021; and

WHEREAS, the Parties seek to amend Section 2 of the Agreement pursuant to this Amendment to reflect a new total not to exceed amount.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

Contractor shall perform maintenance and repair services for the parking access and revenue control systems at the Holley Court Parking Garage and the Avenue Parking Garage in an amount not to exceed ~~\$86,300~~ \$96,800.00 ("Contract Price").

3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
