RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT WITH REVCON TECHNOLOGY GROUP, INC, FOR THE SERVICE AND MAINTENANCE OF PARKING ACCESS AND REVENUE CONTROL SYSTEMS AT THE VILLAGE'S HOLLEY COURT AND AVENUE PARKING GARAGES FOR FISCAL YEAR 2022 IN AN AMOUNT NOT TO EXCEED \$86,300

## **RECITALS**

WHEREAS, the Parties previously entered into a Professional Services Agreement dated December 9, 2020 ("Agreement"); and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$86,300.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
- 2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement through December 31, 2022.
- 3. OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT. All other terms and conditions of the Agreement shall remain in full force and effect.
- 4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
