RESOLUTION

A RESOLUTION AUTHORIZING THE PURCHASE OF EXCESS PUBLIC ENTITY LIABILITY INSURANCE, EXCESS WORKER'S COMPENSATION INSURANCE, PROPERTY AND CASUALTY INSURANCE, CRIME COVERAGE AND CYBER LIABILITY FOR FISCAL YEAR 2023 IN AN AMOUNT NOT TO EXCEED \$707,319

BE IT RESOLVED by the President and Board of Trustees of the Village of Oak Park, Cook County, State of Illinois, in the exercise of their home rule powers, as follows

Section 1. Purchase of Insurance. The Village Manager is hereby authorized and directed to purchase the following insurance for the Village of Oak Park for the 2023 fiscal year and execute any and all necessary documents for the same: (1) excess public entity liability insurance from Safety National Insurance Company and Allied Public Risk/Kinsale/Indian Harbor; (2) excess worker's compensation insurance from Safety National Insurance Company; (3) property and casualty insurance from Affiliated FM Insurance Company, including terrorism coverage; (4) crime insurance from Hanover Insurance Company; and (5) cyber liability from Coalition, Inc. The policy limits for said insurance and deductibles shall be as set forth in the 2023 Insurance Premium Summary spreadsheet, attached hereto and incorporated herein by reference, for the period of January 1, 2023 through December 31, 2023, in the amount of \$707,319.

Section 2. Severability and Repeal of Inconsistent Ordinances, Resolutions and **Motions.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All ordinances, resolutions and motions in conflict herewith are hereby repealed to the extent of such conflict.

Section 3. Effective Date. This Resolution shall be in full force and effect after its adoption and approval as provided by law.
