

**RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND THRIVE COUNSELING CENTER FOR  
CRISIS INTERVENTION AND OTHER POLICE SOCIAL WORK SERVICES**

**THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT DATED DECEMBER 3, 2019** (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and Thrive Counseling Center, an Illinois not-for profit corporation (hereinafter the "Consultant") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

**RECITALS**

**WHEREAS**, the Parties previously entered into an Independent Contractor Agreement dated December 3, 2019 for Crisis Intervention and Other Police Social Work Services ("Agreement"); and

**WHEREAS**, Section 4.1 of the Agreement provides that the Agreement was for a one (1) year term and the Village shall have the right to renew the Agreement for an two (2) additional one (1) year terms.

**WHEREAS**, the Parties seek to renew the Agreement for an additional one (1) year term from 12:01 a.m. on January 1, 2022 through December 31, 2022 at 11:59 p.m. as set forth herein.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of Section 4.1 of the Agreement for an additional one (1) year term, beginning on January 1, 2022 at 12:01 a.m. and ending on December 31, 2022 at 11:59 p.m.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
