

ORDINANCE

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES IN THE AMOUNT OF \$725,000 FOR THE 2021 PROPERTY TAX YEAR FOR VILLAGE OF OAK PARK SPECIAL SERVICE AREA NUMBER ONE

BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Special Service Area Number One. Village of Oak Park (“Village”) Special Service Area Number One was created pursuant to Village Ordinance No. 1973-O-87 entitled “An Ordinance Establishing Village of Oak Park Special Service Area Number One,” adopted December 17, 1973 (“Special Service Area Number One”), which was further extended pursuant to Village Ordinance No. 1987-O-97, adopted on December 7, 1987, and entitled “Ordinance Establishing a Three Percent Property Tax in Special Service Area Number One of the Village of Oak Park.”

Section 2. Tax Levy. The Village of Oak Park hereby levies \$725,000 in taxes for the fiscal year beginning January 1, 2022 and ending December 31, 2022 for the 2021 tax year against the real property subject to Special Service Area Number One.

Section 3. Certification to the Cook County Clerk. There is hereby certified to the County Clerk of Cook County, Illinois, the sum set forth in Section 2 above, which said total amount for Village of Oak Park Special Service Area Number One is required to be raised by taxation for the Village’s 2022 fiscal year, and the Village shall cause a certified copy of this Ordinance to be filed with the Cook County Clerk.

Section 4. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. Effective Date. This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
