

**RENEWAL OF THE TOWING SERVICES AGREEMENT  
BETWEEN THE VILLAGE OF OAK PARK AND O’HARE TRUCK SERVICE, INC., D/B/A O’HARE  
TOWING SERVICE TO PROVIDE TOWING SERVICES**

**THIS RENEWAL OF THE TOWING SERVICES AGREEMENT DATED MAY 24, 2021** (hereinafter referred to as the “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and O’Hare Truck Service, Inc., d/b/a O’Hare Towing Service, an Illinois corporation (hereinafter referred to as the “Contractor”).

**RECITALS**

**WHEREAS**, the Parties previously entered into a Towing Services Agreement dated May 21, 2021 (“Agreement”); and

**WHEREAS**, the Parties entered into a Renewal of the Agreement for a one-year term beginning on June 8, 2023 through June 7, 2024; and

**WHEREAS**, the Parties seek to renew the Agreement for an additional one (1) year term from June 8, 2024 through June 7, 2025 as set forth herein.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed for an additional one (1) year term beginning on June 8, 2024 through June 7, 2025.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
