

**RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND METRO STRATEGIES GROUP, LLC  
IN AN AMOUNT NOT TO EXCEED \$100,000**

**THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT** (hereinafter referred to as the “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and Metro Strategies Group, LLC, an Illinois limited liability company (hereinafter referred to as the “Consultant”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

**RECITALS**

**WHEREAS**, the Parties previously entered into a Professional Services Agreement dated July 31, 2023 (“Agreement”), as previously renewed pursuant to the Renewal of the Professional Services Agreement dated June 18, 2024; and

**WHEREAS**, the Parties seek to further renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$100,000.00.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement for an additional one (1) year term beginning on August 1, 2025 and ending on July 31, 2026, subject to the ratification and approval by the Village’s Corporate Authorities.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on August 1, 2025.
