Dear Village of Oak Park Plan Commission Chair and Commissioners,

I am writing to voice my support for the proposed development at 1106 Madison Street. As a homeowner near this site and a person who has worked for years running organizations that provide supportive housing, affordable housing, substance use and/or mental health services to the most marginalized populations, I am proud of Oak Park taking leadership in creating access to affordable and accessible housing options.

Our country is in an affordable housing crisis. According to the National Low Income Housing Coalition:

- Nationally, there is a shortage of more than 7 million affordable homes for our nation's 11 million plus extremely low-income families;
- Seventy percent of all extremely low-income families are severely cost-burdened, paying more than half their income on rent;
- There is no state or county in our country where a renter working full-time at minimum wage can afford a two-bedroom apartment;
- In Illinois, a renter making minimum wage would have to work 80 hours a week to afford a twobedroom rental unit.

I chose to move to Oak Park 17 years ago because I wanted to be a part of a community that does better than our dismal national averages. But, when you look at the average rental prices in our community, we are not doing well. Based on the Metropolitan Mayor's Caucus "Strategic Vision for Housing" presented to the Village Board in March 2024, Oak Park has an affordable housing crisis:

- 75% of Oak Park's renter households with incomes below \$50,000 are housing cost burdened.
- The rental vacancy rate in Oak Park has been less than 7% since 2016 (a 7% vacancy rate is generally considered to be a healthy vacancy rate.) Affordable housing providers report vacancy rates around 1-2%.

As a result of these and other factors, the median rent in Oak Park has been rising faster than incomes across the region over the previous decade. We could continue to pretend that there is not a problem in our community, or we can do something about it. **My vote is that we do something about it.**

1106 Madison Street will not fix our housing crisis, nationally nor in my 60304 zip code. However, it moves us in the right direction in many ways: (1) it breaks a terrible trend where for-profit developers would rather pay a small fine rather than set aside units for affordable housing, (2) Oak Park has such rich offerings through our schools, park district, libraries, restaurants and businesses, (3) we all benefit from increasing diversity (race, religion, and socio-economic) in our neighborhoods.

It can also not be overstated that the project will be led by two agencies that have a proven track record of competence and accountability: Housing Forward and Interfaith Housing Development Corporation.

They each have decades-long experience in the field and the ability to deliver on their promises, unlike many Oak Park for-profit developers. In line with Oak Park's goals of diversity and inclusion, their vision will provide our community with 36 units of permanent supportive housing and wrap-around supportive services targeted to individuals with a chronic disability. Also in line with Oak Park's sustainability goals, the building will include solar panels and be fully electric.

I whole-heartedly support the proposed development, 1106 Madison in my community. While one building cannot solve all of the problems of affordable housing, diversity, or climate change, 1106 Madison demonstrates that we can move in the right direction while being consistent with the values of our Oak Park community.

To the Members of the Plan Commission,

I am writing in fervent support of Housing Forward's planned supportive housing building for those with chronic disabilities, to be located at 1106 Madison.

As a local Realtor, I have had countless hard conversations with would-be tenants and their family members, looking for rental housing in elevator buildings that is appropriate and available to those with little financial wherewithal (e.g. SSDI as their only source of income). There is virtually none.

Furthermore, as the parent of such a young adult, currently living at home, I am all too aware of the looming housing challenge that will face him and his sibling when my husband and I can no longer care for him here. As you may know, a local advocacy group comprised of other such parents facing this very need recently arose from the planning process of last year's housing study. The need is acute!

The bottom line is that within Oak Park's and the region's overall lack of affordable housing, the lack of suitable housing for such individuals is even greater. Typically, they are overlooked or forgotten because they are out-of-sight and often cannot advocate for themselves.

The building as planned has a multitude of positive attributes: a multi-story building = increased density = the "greenest" way to develop in the 21st century. Its sustainable bonafides will include solar power for its 100% electric energy use, per the Village's Climate Ready plan. It is easily accessible to both bus and trains for those who can utilize public transportation (and for their family members and in-home care providers, as needed, to reach them). Its location directly across the street from Rush Hospital provides accessible healthcare options for the residents.

The co-developer, Interfaith Housing, has a proven record with the Grove Apartments, and Housing Forward has been very successful with their scattered site model meeting the specific needs of those transitioning out of various unhoused situations (e.g. those being released from the hospital at Sojourner House, families who need larger units at Ohana House).

This project seems to me to exemplify all that is good in Oak Park. It provides a concrete way "to live our values" and I hope you will agree to enthusiastically support it.
