Al Warren Oil Co., Inc. shall remit to the NWMC Purchasing Manager on a quarterly basis, an amount equal to 0.5 % of the total dollar volume for the quarter. Contractor must furnish a report of purchases made from the contract by the last of the month following the end of each fiscal quarter:

Quarter 1 - May, June, July, due August 31

Quarter 2 – August, September, October, due November 30

Quarter 3 - November, December, January, due February 28

Quarter 4 - February, March, April, due May 31

This report is to be submitted to the NWMC Purchasing Director in Excel via email to <a href="edgyan@nwmccog.org">edgyan@nwmccog.org</a>, and mailed to 1600 East Golf Road, Suite 0700, Des Plaines, Illinois 60016 and shall include the following information: ordering municipality, date of order, date of delivery, item descriptions, total quantity delivered, item price (including mark-up and applicable taxes), total order extended price, and total volume for the quarter.
