

**EXTENSION OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE
VILLAGE OF OAK PARK AND THRIVE COUNSELING CENTER FOR CRISIS INTERVENTION
AND OTHER POLICE SOCIAL SERVICES**

THIS EXTENSION OF THE INDEPENDENT CONTRACTOR AGREEMENT DATED DECEMBER 3, 2019 (hereinafter “Extension”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the “Village”), and Thrive Counseling Center, an Illinois not-for-profit corporation (hereinafter the “Consultant”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

RECITALS

WHEREAS, the Parties previously entered into an Independent Contractor Agreement dated December 3, 2019 for Crisis Intervention and Other Police Social Work Services reports (“Agreement”); and

WHEREAS, the Parties seek to extend the Agreement for an additional eight (8) month term from 12:01 a.m. on November 1, 2025 through June 30, 2026 at 11:59 p.m. as set forth herein.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **EXTENSION OF AGREEMENT.** The Agreement between the Parties is hereby extended for an additional six (6) month term, beginning on November 1, 2025 at 12:01 a.m. and ending on June 30, 2026 at 11:59 p.m. for an amount not to exceed \$110,667. As part of said extension, the Consultant shall offer counseling services for referrals provided by the Village’s Administrative Adjudication system.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
