The residents had earlier tested positive for the virus, but the final cause of death will be determined by the Cook County Medical Examiner. The Village expresses sincere condolences to the families for the loss of their loved ones.

Public Health Communications

In response to the Governor issuing [Executive Order 2020-32](#) (COVID-19 – Executive Order 30) last night, the Public Health Director provided the following public notices today:

- A fact sheet related to COVID-19 – Executive Order 30 was created and was distributed to Oak Park businesses via email. A total 1,121 emails were sent out to Oak Park businesses that provided emails to the Village previously with their business licensing application in the CityView system used by Development Customer Services. Additionally, the fact sheet has been posted on the Village's COVID-19 webpage.
- As noted above, the Village updated the COVID-19 Public Health SUPPLEMENTAL ORDER-SOCIAL DISTANCING REQUIREMENTS FOR STORES THAT SELL GROCERIES. This document was emailed to 21 grocery stores and staff also hand-delivered this document to 21 grocery stores. Additionally, the fact sheet has been posted on the Village's COVID-19 webpage.

Director Charley also noted the support he received from staff in various departments as well as the Public Health staff team in accomplishing the above work.

Village Board Meeting

On Monday, May 4, 2020, at 6:30 p.m. a Remote Participation Meeting of the Village Board is being conducted with live audio available and optional video of the Village Officials. The meeting will be streamed live and archived online for on-demand viewing at www.oak-park.us/boardtv as well as cablecast on VOP-TV, which is available to Comcast subscribers on channel 6 and ATT Uverse subscribers on channel 99. Remote Meetings of the Oak Park Village Board of Trustees is authorized pursuant to Section 6 of Governor J.B. Pritzker's Executive Order 2020-07.

The agenda and materials are available on the Village website. In compliance with the Executive Order of the Governor the agenda is limited to matters necessary during the Village's emergency response to the COVID-19 outbreak.

Fifty Days

May 1 marked the completion of 50 consecutive days of municipal response since the Village of Oak Park declared an emergency affective public health. It was noted that the news from from Director Charley about the tenth and eleventh death of Oak Park residents believed to be related to the COVID-19 coronavirus, remains difficult to reconcile.

This Pandemic is being reported in terms of statistical measures. However for the Village staff that is working every day to maintain core municipal services which can only be delivered by a workforce that is provided a safe work environment, the loss of every resident is especially challenging. I ask for the Village Boards understanding that things are not business as usual and we cannot flip a switch and work in the same way that we did prior to March 13, 2020, when the Village Board first declared an emergency affective public health.

Thank you to our Village employees who are working in response to this emergency. I am deeply grateful for every employee, their dedication and professionalism during this time.

Public Works makes temporary changes to Pedestrian Walk Signals

The Village has temporarily placed approximate 25 pedestrian signals into automatic recall and installed laminated signage over the pedestrian push buttons in the Village which eliminates the need to residents to “push” the button at most intersections to obtain a “walk” light. For IDOT signals within the Village limits, we have requested IDOT’s approval to implement these same measures in their pedestrian signals during this same time period. Staff will be monitoring conditions but anticipate returning the pedestrian signals to normal operations following the public health emergency.

Remote meetings of Oak Park Citizen Commissions are authorized pursuant to Section 6 of Governor J.B. Pritzker's Executive Order 2020-07, with limitations.

Governor Pritzker's Executive Order allows for remote participation meetings by public bodies, but public bodies are "encouraged to postpone" meetings and should only hold meetings when

"necessary." Executive Order No. 2020-07 (COVID-19 Executive Order No. 5) at Section 6. The Illinois Attorney General issued "Guidance to Public Bodies" regarding the Governor's Executive Order on April 9, 2020. In that guidance, the Attorney General states, "Where a public body does not have critical issues that must be addressed because time is of the essence, cancelling or postponing public meetings may be prudent during the COVID-19 outbreak, rather than holding meetings that could pose a risk of danger to the public."

Restore Illinois

Yesterday, Governor JB Pritzker announced the creation of his "Restore Illinois" plan available at <http://dph.illinois.gov/covid19> which is a five-phase plan to safely reopen the state's economy. As of May 1, the entire state is in Phase 2 (flattening). Oak Park is in Region 8 and part of the larger

Northeast Regions 7-11 for purposes of tracking public health data and reaching benchmarks which would allow for a transition from the current Phase 2 classification into a Phase 3 classification of “recovery” which would allow for re-opening to the public of additional employment and service industries identified by the State. Oak Park’s Region 8 designation is consistent with Oak Park’s existing Emergency Medical Services (EMS) Region 8 where Loyola University Medical Center’s Dr. Cichon is the Medical Director for all Village of Oak Park Firefighter/Paramedics.

Further, these Regions align with the Illinois Healthcare Coalitions where Illinois hospitals historically have collaborated to improve emergency preparedness. Through regional healthcare coalitions, hospitals can work together to prepare for, respond to and recover from incidents. The healthcare coalition’s primary function is to engage in emergency preparedness activities. Each coalition is led by an individual healthcare organization or the Regional Hospital Coordinating Center (RHCC). Loyola is the RHCC for Region 8 and it is their role to:

- Coordinates coalition partners;
- Acts as a liaison between the Illinois Department of Public Health and local partners;
- Provides situational awareness; and
- Shares information and resources.

Council of Governments (COG)

The Oak Park COG held a GoToMeetings call today combined with the River Forest and Forest Park COGs. The COG is the chief elected and chief appointed official from each taxing body and has allowed for important discussion around shared actions and shared information.

Public Service Recognition Week

This is Public Service Recognition Week, which has been celebrated the first week of May since 1985 to honor federal, state, county and local government employees.

As the COVID-19 pandemic continues, the role of municipal employees in maintaining local government services is more apparent than ever. Even with all Village of Oak Park municipal government facilities except the Police Department lobby are closed to the public through May, Village employees continues to provide a high level of service for the community during these difficult times.

Police officers and firefighter/paramedics are on duty. Public Health is at work. Key Public Works Department workers who provide essential service also remain on duty along with essential administrative support staff. Other employees whose functions promote public safety are working on a case-by-case basis, and many Village employees continue to work remotely.

Behind this all, is the Village’s management team who continue works within a virtual Emergency Operations Center (EOC) that is the backbone of information management, decision-making, and resource allocation and serves to gather and process all of the information required to plan for and respond – quickly and effectively – to this pandemic emergency. Village Staff Deliver Necessary Services during Stay Home Order

In order to correct misinformation circulating on social media, please note that since March 16, 2020, the Development Customer Services Department has remotely processed 356 building permits and conducted 472 inspections (451 in person and 12 virtual) to ensure that "critical trades" in the construction field - as defined by the Governor's Stay at Home Order as essential - can continue in accordance with Village building codes. Additionally, staff has issued Certificates of Occupancy to Daly Bagel, Turanos Corporate office and two single family homes during the Stay Home Order. Planning staff has performed 905 historic and zoning reviews, issued ten Certificates of Appropriateness and is processing ten Planning Applications for pending development projects. Parking staff has processed 4,515 quarterly parking permits. As noted in prior reports, staff from Neighborhood Services has delivered 225 meals to seniors and have processed/inspected 62 property maintenance complaints for such things as work without a permit, graffiti and other property conditions. Additionally, the Department continues to process business licenses, liquor license renewals and answer questions for new businesses seeking to open in the Village.

Management Council

The Management Council met to continuing dialogue about coordinated efforts in response to COVID-19 as well planning discussions related to Restore Illinois.

Block parties suspended until COVID-19 threat eases

All block parties have been suspended, in compliance with the *Restore Illinois* plan issued last week by Gov. J.B. Pritzker, until the fourth phase of the plan is reached when gatherings of up to 50 people are permitted. In the meantime, the Village is communicating with who had already submitted a request to hold a block party.

- CHAMP (ComEd Helps Active/Disabled Military Personnel)**
 ComEd offers a benefit package to assist eligible active duty members of the U.S. Armed Forces, National Guard, Reserves and veterans who have fallen behind on their energy bill. Eligible customers may receive a grant up to \$1,000 towards their ComEd bill, as well as benefits such as deposit reduction and/or cancellation of late payment charges, if applicable.
- ComEd's Residential Special Hardship**
 This program assists residential customers, who have a household income up to 250 percent of the federal poverty level, with a past-due balance and demonstrates a financial hardship. Eligible customers may receive a grant of up to \$500 once every two years, to be applied to their ComEd bill.
- ComEd's Non-Residential Special Hardship**
 This program assists nonprofit organizations, including faith-based organizations, who are experiencing a financial hardship. Eligible organizations are required to complete an energy-management workshop or webinar and may receive up to \$2,000 toward their ComEd bill.
- ComEd's H.E.A.L. (Hospital-Based Energy Assistance & Long-term Health) Program**

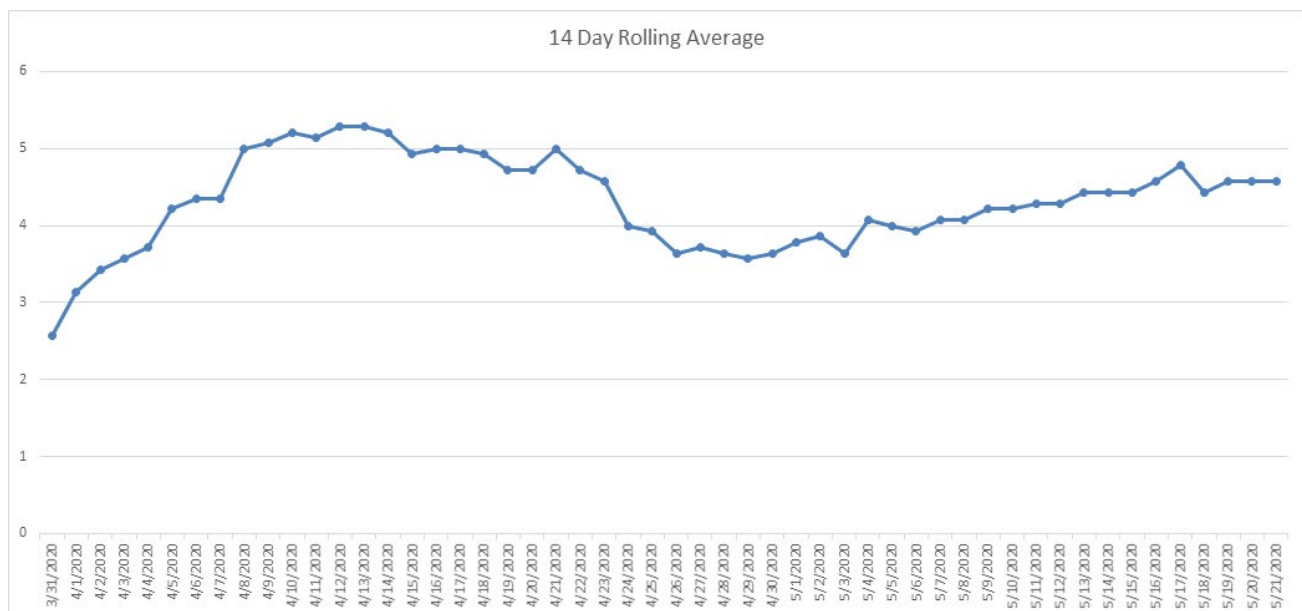

Restore Illinois and Pending Move to Phase 3

Public Health Director Charley emailed all Oak Park business license holders about Governor JB Pritzker's announcement that all regions of the state will move to Phase 3 of the Restore Illinois Plan as early as May 29. Moving to Phase 3 will allow more activity at most Oak Park businesses. The goal of the Village's Public Health Department is to increase activity and business opening in conjunction with the state and to get back to normalcy as much as possible without jeopardizing the health and safety of residents, visitors and employees.

In order to know what specifically the state will require of each business prior to its opening in Phase 3, the Village is awaiting specific state guidance that has not yet been issued.

Here is what the Oak Park Public Health Department reports that they know today regarding the State's Restore Illinois plan.

- **Bars and Restaurants** may open for delivery, pickup, drive-through and outdoor seating. Prior to opening outdoor seating located on public property (such as street or sidewalk), a permit will be required. The permit process will be to establish the locations where tables, which must be at least six (6) feet apart and away from sidewalks, can be located. Staff must wear face coverings and practice social distancing.
- **Tennis** facilities, both indoor and outdoor, will be allowed to reopening with state safety precautions and capacity limits.
- **Health clubs**, gyms and fitness facilities will be allowed to provide one-on-one personal training in indoor facilities and outdoor fitness classes of up to 10 people.
- **Retail stores** will be allowed to reopen to shoppers, but must follow state safety precautions and capacity limits. Face coverings will be required for both staff and shoppers.
- **Personal care services** like nail salons, tattoo shops, hair braiders, spas and barbershops will be allowed to open but must follow state safety precautions and capacity limits.
- **Non-essential manufacturing** that can operate within social distancing guidelines may reopen with state-approved safety guidance.
- **Employees of non-essential businesses** may return to work with state-approved safety guidance depending upon risk level. However, tele-work strongly encouraged wherever possible. Employers are encouraged to provide accommodations for COVID-19-vulnerable employees

Within the coming days, the Illinois Department of Commerce and Economic Opportunity (IDCEO) is expected to release reopening guidelines that should help answer specific questions regarding the transition to Phase 3 of Restore Illinois. The guidelines are expected to address the following:

- **General health requirements**, including plans employers must have for social distancing, working from home, handwashing and other related issues.
- **Human resources and travel policies** related to health and safety and training employees must complete prior to returning to work, including limits on travel.

- **Health monitoring**, including conducting temperature screenings and following state guidance regarding sick employees.
- **Physical workplace** requirements including social distancing signage, proper space configuration for employees, removing shared items, providing hand sanitizer and environmental cleaning.

The Oak Park Public Health Department is working closely with the Village's Department of Development Customer Services who will also communicate direction with business license holders in Oak Park about specific information provided by the state.

Construction at the intersection of Lake and Oak Park Avenue

Public Works reports that water and sewer work is complete in the Lake and Oak Park Avenue intersection. Utility work by Nicor & AT&T is nearly completed. In order to expedite the streetscape project and minimize future disruptions, the electrical contractor for the streetscape project will be installing conduits and various underground electrical items in the intersection starting next week for the future traffic signal, street lighting, and communications work here. After the electrical items are completed the streetscape contractor will pour a new concrete base and new asphalt surface for the entire intersection to allow for the subsequent reopening to vehicular traffic.

Restore Illinois

Public Health Director Charley emailed more than 1,000 Oak Park business license holders to ensure they are aware of the State of Illinois [Phase 3 guidelines for business operations](#) as well as [business toolkits](#) containing resources to help businesses comply with public health recommendations.

Phase 3 guidelines span 10 different industry categories, each has a common set of guidelines as well as workplace and program-specific guidelines.

Additionally, business license holders were reminded that the State has not yet set an official date for moving into Phase 3 (the Governor has stated that all regions of the state will likely enter Phase 3 of the plan on Friday, May 29, 2020) and therefore the Village of Oak Park is planning for this to occur as early as Friday, May 29. Businesses were also provided a list of staff members who are tasked with working directly with each unique group as Illinois moves into Phase 3 of [Restore Illinois](#).

The Oak Park Public Health Department is working closely with the Village's Department of Development Customer Services to assist business owners and operators during the pandemic. Local information for businesses and other organizations is posted on the Village website at www.oak-park.us/businessguidance.

Additionally, Director Charley emailed all Oak Park licensed child care centers to provide specific guidance issued by the state regarding reopening child care in Illinois. Issued by the Illinois Department of Public Health (IDPH) the information is especially important for licensed child care centers & homes to reopen as the State enters Phase 3 of the Restore Illinois plan. While many child care homes and centers have been open and providing emergency care to the children of essential workers during the COVID-19 public health crisis under an emergency license obtained through DCFS, the majority of licensed child care programs have been closed during Phases 1 and 2 of the [Restore Illinois Plan](#). Starting in Phase 3 and continuing through Phase 4, child care providers are encouraged to reopen subject to guidance from the Illinois Department of Public Health to serve the many families who will be returning to work.

Phase 3 Preparations

Staff communicated with restaurants that have had previously sidewalk dining permits a new document - the Village's Preliminary Outdoor Dining on Public Sidewalks Guidance. At this point, it is our understanding that our region of the state will move to the Phase 3, of Governor JB Pritzker's "Restore Illinois" plan as early as Friday, May 29, 2020. Staff is working to being permitting outdoor dining for restaurants that had permits last year as our first priority in order for interested businesses to set up their sidewalk dining. In addition, next week, staff will begin to process additional locations on a case by case basis. Existing businesses that solely use a private patio or rooftop for outdoor dining do not need a permit under the State's guidance and must follow social distancing and state public health guidance. Subject to the Village Board's approval on May 28, 2020 there is not a fee associated with the permit for use of the sidewalk.

Communication with restaurants is posted on the Village website at www.oak-park.us/businessguidance.

It is also noted that the State of Illinois Department of Commerce and Economic Opportunity (DCEO) is regularly answering regarding their Phase 3 (Recovery) guidelines. Some of the most recent information is below:

- Pickleball courts are allowed to operate under the [tennis guidelines \(available via this link\)](#).
- Splash pads and water "parks" should remain closed and therefore no Village fountains/water features are being opened at this time.
- Facials and facial waxing services that do not allow for the wearing of face coverings are prohibited.
- Massages are limited to 30 minutes per [DCEO's personal care services guidelines \(available via this link\)](#).
- Private pools at homeowners associations and condominiums are allowed to open. Public pools, including business and fitness related pools, should remain closed.
- Tents for outdoor dining are permissible but tent sides must remain open. Restaurants and bars are required to have tables, standing room only is not allowed. There is currently no guidance on the size of tables, but they must remain six feet apart. Parking lot, sidewalk or street usage for outdoor dining will be left to the local jurisdiction, including hours of operation.

Phase 3 Preparations

All regions of the state will move into Phase 3 (Recovery) of the “Restore Illinois” plan starting tomorrow, Friday, May 29. The Governor announced during his daily press briefing that the same criteria used to determine if a region could move into Phase 3 will also be used to determine if a region can move into Phase 4 (Revitalization). The earliest that a region can move into Phase 4 is Friday, June 26. Staff continues to work to review state guidance and communicate it to applicable groups. A number of updates tomorrow will be publicly announced, subject to the outcome of the 5 p.m. Village Board meeting.

Yesterday, DCEO provided a general statement regarding both public and private (at homeowners associations and condominiums) pools. **DCEO now indicates that all pools should not be opened until detailed guidance is provided by IDPH.**

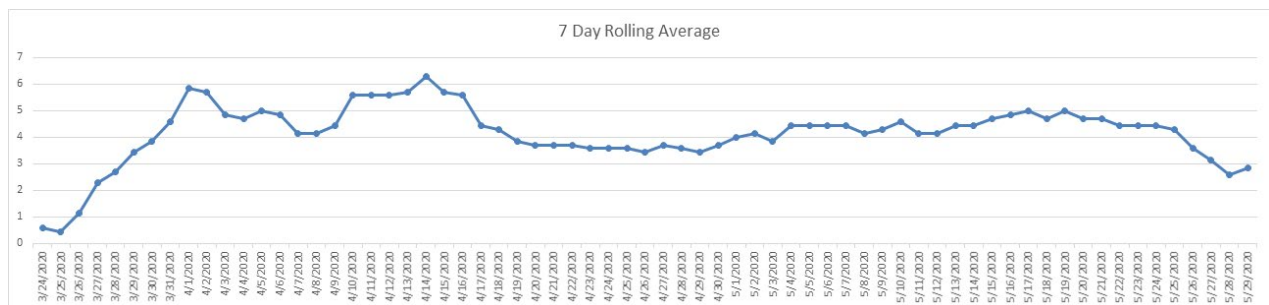
Governor Pritzker is expected to sign legislation that would allow public bodies to conduct remote meetings under certain conditions. Under the legislation, public bodies will be allowed to hold remote meetings only when a disaster declaration has been issued by the Governor or the Director of the Illinois Department of Public Health, with other restrictions. These new conditions and requirements for remote meetings will go into effect when the Governor signs the legislation into law.

Cases related to Long-Term Care and Assisted Living Facilities

The Oak Park Public Health Department has been consistently reporting cases of residents in Oak Park senior facilities where Assisted Living or skilled nursing care is provided. The Village of Oak Park has five facilities which meet the above definitions (it is noted that some of the Long Term

Care and Assisted Living facilities in Oak Park also have within their property some independent living units.) That date is reported daily in the chart below which remains unchanged today.

Additionally, Oak Park has reported on cases in its Independent Senior Living facilities, which function more like an apartment building, but limit access to individual by age and in some cases age and income. These Senior Buildings are not included in the chart. Today, Public Health Director Charley has report a new positive case (the sixth) at the Heritage House, 201 Lake Street the facilities first cast was reported on April 18, 2020. The Public Health Director is consulting with the property manager on this matter.

Phase 3 Opening

Oak Park has joined communities across the state in easing restrictions on businesses and recreation as Phase 3 of Gov. J.B. Pritzker's five-phase [Restore Illinois](#) plan goes into effect today. The state will determine if a region can move into Phase 4 (Revitalization). The earliest that a region can move into Phase 4 is Friday, June 26.

Along with the state entering Phase 3 today, Governor Pritzker announced an end to his Stay at Home Order. He did sign a new Gubernatorial Disaster Proclamation extending the statewide disaster declaration through Saturday, June 27, 2020. The Governor additionally Executive Order 2020-38 called the Community Recovery Order, which supersedes the previous Stay at Home Order to reflect the changes allowed in Phase 3 under the Restore Illinois Plan.

The Governor also signed Executive Order 2020-39 extending previous executive orders. That includes extending Executive Order 2020-07 which suspended certain provisions of the Open Meetings Act (OMA), including the in-person quorum requirements and conditions limiting when remote participation is permitted, through June 27, 2020, or until Senate Bill 2135 is enacted into law whichever occurs first.

As the Village works to align with the State's actions this afternoon, Oak Park Public Health Director has rescinded his prior Public Health Order related to sports courts. Additionally, Development Customer Services has sidewalk dining permits to:

Authority for Village staff to issue the above sidewalk permits, was granted by the Village Board on May 28, 2020, under Ordinance 20-043.

A temporary use permit was also issued to Al's Grill, 1100 Madison Street, to utilize their private parking lot for outdoor dining. The Temporary Use Permit is authorized, without a fee, in Section 8.5(D)-(E) and (G) of the Zoning Code and enables the temporary use of a private parking lot for outdoor dining.

Temporary easing of parking restrictions extended

The Village will continue to allow on-street, overnight and daytime parking on most Oak Park residential streets to accommodate residents as we transition from the COVID-19 emergency response into the Phase 3 recovery. Restrictions are scheduled to resume at 2:30 a.m., Mon., July 13. Please keep in mind restrictions remain in effect in metered and pay station spaces, and in paid overnight permit areas, including posted on-street zones and lots. All parking regulations related to traffic and public safety such as no parking here to corner or in front of a fire hydrant also remain in effect.

Distribution of Cloth Face Masks

The Oak Park Police Department distributed over 400 cloth face coverings to residents to date. Residents who need a cloth face covering can stop at the Police Station lobby 24/7.
