

**RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE VILLAGE OF OAK PARK  
AND MESIROW INSURANCE SERVICES, INC.**

**THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT DATED JUNE 21, 2017** (hereinafter referred to as the “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and Mesirow Insurance, Inc., d/b/a Alliant/Mesirow Insurance Services, an Illinois corporation (hereinafter referred to as the “Contractor”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

**RECITALS**

**WHEREAS**, the Parties previously entered into Service Agreement dated October 2, 2018 (“Agreement”) for the Contractor to provide research and evaluate the insurance marketplace for the Village’s insurance program, including, but not limited to public entity liability, excess workers’ compensation, property and casualty, and crime insurance coverage and other services as set forth in the Agreement; and

**WHEREAS**, the Parties seek to renew the Agreement for a one (1) year term beginning on January 1, 2022 and ending on December 31, 2022 at the same fee set forth in the Agreement.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed for an additional one (1) year term beginning on January 1, 2022 and ending on December 31, 2022 at the same fee set forth in the Agreement.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect, except as set forth herein.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
