

**AN AMENDMENT TO A PROFESSIONAL SERVICES AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND HR GREEN, INC., FOR AN AMOUNT NOT TO EXCEED \$115,000**

**THIS AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT DATED** March 26, 2015 between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as "Village"), and HR Green, Inc., an Illinois corporation (hereinafter referred to as "Contractor"), is entered into this 3rd day of November, 2015 (collectively referred to as the "Parties").

**RECITALS**

**WHEREAS**, the Parties entered into a Professional Services Agreement dated March 26, 2015 ("Agreement"); and

**WHEREAS**, the Parties seek to amend Section 2 ("Services of the Contractor") of the Agreement to include Acting Chief Building Official activities and electrical inspections of the Agreement pursuant to this Amendment as additional services to be performed by the Contractor for a total amount of \$115,000.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the "Additional Scope of Work Amendment," attached hereto and incorporated herein by reference, as part of the Agreement to reflect additional services by the Contractor due its performance of Acting Chief Building Code Official activities and electrical inspections for an additional total amount not to exceed \$115,000.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
