Proposed Improvement: The Improvements will consists of the removal and resetting, relocating, and/or replacing sandstone and slate sidewalk in various locations throughout the Village and Includes Colored PCC sidewalk, removal of PCC sidewalks, Parkway Restoration and traffic control: and all appurtenant work thereto.

Bidders Instructions

1. Plans and proposal forms will be available in the Office of the Village Engineer, 201 South Boulevard, Oak Park, Illinois 60302. No plans will be issued to prospective bidders after **4 P.M.** on the working day preceding the opening of bids. Proposals will not be accepted by the Village of Oak Park from Contractors who have failed to provide payment, if required, for obtaining proposal forms and have also failed to register with the Engineering Division of the Public Works Department as plan holders for this project.
2. At the bid opening, all proposals must be accompanied by a proposal guaranty in the amount of 5% of the bid amount. The proposal guaranty shall be in the form of a bid bond executed by a corporate surety company or a bank cashier's check.

3. If this proposal is accepted and the undersigned fails to execute an agreement and contract bond within ten (10) days after the Notice of Award, it is hereby agreed that the bid bond or check shall be forfeited to the Village.
4. The awarding authority reserves the right to waive technicalities and to reject any or all proposals as provided in Article 102.01 of the 2016 "Standard Specifications for Road and Bridge Construction," prepared by the Illinois Department of Transportation.

This work shall consist of the removing and re-leveling pieces of sandstone that have been broken on the corners using concrete.

Basis of Payment

This work will be paid for at the contractor unit price Each Historic sidewalk Corner Repair which shall be payment in full for all labor, transportation, and disposal required to complete the work described herein.

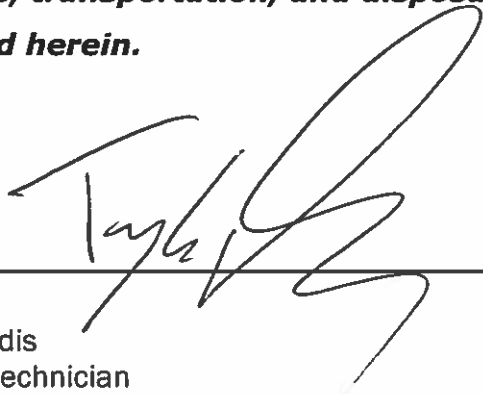

General

This work shall consist of releveling broken corners of sandstone sidewalk squares as directed by the engineer. Sandstone sidewalk squares with broken corners shall be repaired by removing the broken pieces and underlying sub-base by hand, pouring a minimum 2 inch thick concrete bed, and resetting the corner pieces to meet the unbroken portion of sandstone sidewalk square. The pieces shall be set into the wet concrete and protected from disturbance until the concrete has set. Corner pieces to be replaced shall be no larger than ¼ of a sandstone sidewalk square. The contractor shall take care to not splash or place wet concrete onto the sandstone sidewalk, and will be responsible for cleaning any sandstone sidewalk impacted during construction.
