## RENEWAL OF AN INDEPENDENT CONTRACTOR AGREEMENT BETWEEN THE VILLAGE OF OAK PARK AND O'HARE TRUCK SERVICE, INC., D/B/A O'HARE TOWING SERVICE TO PROVIDE TOWING SERVICES

THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT DATE MAY 24, 2021, (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and O'Hare Truck Service, Inc. d/b/a O'Hare Towing Service, an Illinois Corporation (herein the "Contractor").

### RECITALS

WHEREAS, the Parties previously entered into an Independent Contractor Agreement dated May 24, 2021 for towing services ("Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides that the Agreement was for a two (2) year term and the Village shall have the right to renew the Agreement for an additional one (1) year term.

WHEREAS, the Parties seek to renew the Agreement for an additional one (1) year term from June 8, 2023 through June 7, 2024 as set forth herein.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:


1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of Section 4.1 of the Agreement for an additional one (1) year term, beginning on June 8, 2023 through June 7, 2024.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.


