

**RENEWAL OF AN INDEPENDENT CONTRACTOR AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND G. A. PAVING CONSTRUCTION, INC. IN AN  
AMOUNT NOT TO EXCEED \$175,000 FOR SNOW PLOWING AND SALTING OF  
VILLAGE LEASED/OWNED PARKING LOTS AND BACK-UP SNOW REMOVAL  
FOR PUBLIC STREETS FOR THE 2020 SNOW SEASON**

**THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT** (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and G. A. Paving Construction, Inc. an Illinois corporation (hereinafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

**RECITALS**

**WHEREAS**, the Parties previously entered into an Independent Contractor Agreement dated December 11, 2017 ("Agreement") and a renewal dated December 10, 2019 ("Agreement"); and

**WHEREAS**, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$175,000 for snow plowing and salting of Village leased/owned parking lots and back-up snow removal for public streets for 2020 snow season.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of Section 4 of the Agreement for an additional one (1) year term through December 31, 2020.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the parties as reflected below.
