

PURCHASE PRICE AGREEMENT

THIS PURCHASE PRICE AGREEMENT (hereinafter referred to as the “Agreement”) is entered onto on the ____ day of December, 2021, by and between the Village of Oak Park (hereinafter referred to as the “Village”), an Illinois home rule municipal corporation, 123 Madison Street, Oak Park, Illinois 60302 and SNI Solutions, Inc., an Illinois Corporation with offices at 205 N. Stewart, Geneseo, Illinois 61254 (herein after referred to as the “Contractor”).

1. Price

Contractor is a supplier of Ecosalt & Geomelt deicers (“Materials”). Contractor has provided the Village with 2022 prices for its Materials as set forth in its Proposal dated November 4, 2021, attached hereto and incorporated herein by reference. The Village accepts the prices set forth in the Proposal and agrees to purchase from Contractor such Materials as it finds necessary at the prices set forth in the Proposal. The prices set forth in the Proposal shall be in effect through April 30, 2022. The Contractor shall provide the Village with prices for the remainder of 2022. The Village has the sole right to accept those prices or terminate this Agreement at its sole discretion pursuant to written notice from the Village Manager or the Manager’s designee. This Agreement does not commit the Village to purchase any specific quantity of Materials. The total amount of materials to be purchased pursuant to this Agreement shall not exceed \$35,000.00.

2. Tax Exempt

The Village, as a local governmental entity, is exempt from the payment of State of Illinois sales tax or retailer’s occupation taxes. Contractor shall not include any amount for such sales taxes or retailer’s occupation taxes in its invoices.

3. Payment

The Village will pay all undisputed portions of invoices within 30 days of approval as provided in the Local Government Prompt Payment Act, 50 ILCS 505/4. The maximum interest rate for any payment not made within thirty (30) days of approval is 1% per month.

4. Term of Agreement

This Agreement is valid for purchases through December 31, 2022 or until such time as this Agreement might be terminated as set forth herein.

5. Governing Law and Venue

This Agreement is governed by the laws of the State of Illinois without regard to conflicts of law principals. Any action brought to enforce this Agreement must be brought in the state and/or federal courts located in Cook County, Illinois.

6. Conflict

In case of a conflict between any provision(s) of this Agreement and the Contractor’s Proposal, this Agreement shall control to the extent of such conflict.

7. Dispute Resolution

The Village does not agree to the mandatory arbitration of any dispute. In the event any action is brought to enforce this Agreement or to collect any unpaid amount from the Village, each party hereto shall bear the responsibility of paying its own attorney’s fees and costs.

8. Binding Authority

The individuals executing this Agreement on behalf of the Parties represent that they have the legal power, right and actual authority to bind their respective party to the terms and conditions of this Agreement. A facsimile or pdf/email copy of this Agreement and any signatures thereon will be considered for all purposes as an original.

THE PARTIES TO THIS AGREEMENT by their signatures acknowledge they have read and understand this Agreement and intend to be bound by its terms.
