

## **PURCHASE PRICE AGREEMENT**

**THIS PURCHASE PRICE AGREEMENT** (hereinafter referred to as the “Agreement”) is entered into on the \_\_\_\_\_ day of December, 2025, by and between the Village of Oak Park (hereinafter referred to as the “Village”), an Illinois home rule municipal corporation, 123 Madison Street, Oak Park, Illinois 60302 and Al Warren Oil Company, Inc. and Illinois corporation with offices at 208 S. LaSalle Street, Suite 814, Chicago, IL 60604 (hereinafter referred to as the “Contractor”).

### **1. Price**

Contractor is a supplier of fuel, including gasoline, diesel, and B20 Bio Diesel (“Materials”). Contractor participates in the Suburban Purchasing Cooperative (SPC) and has provided the Village with a copy of the SPC renewal letter dated May 12, 2025, attached hereto and incorporated herein by reference. The Village accepts prices are based on Oil Price Information Service (OPIS) Low Chicago published price per gallon dated May 6, 2024, plus or minus the bidder’s profit/overhead (“contractor mark-up”). The OPS Chicago sheet for May 6 must be attached to the bid. The price per gallon will be based on the low posted for the day of delivery. The mark-up amount will remain firm throughout the term of the contract. This Agreement does not commit the Village to purchase any specific quantity of Materials. The total amount of Materials to be purchased pursuant to this Agreement shall not exceed \$300,000.00.

### **2. Tax Exempt**

The Village, as a local governmental entity, is exempt from the payment of State of Illinois sales tax or retailer’s occupation taxes.

### **3. Payment**

The Village will pay all undisputed portions of invoices within 30 days of approval as provided in the Local Government Prompt Payment Act, 50 ILCS 505/4. The maximum interest rate for any payment not made within thirty (30) days of approval is 1% per month.

### **4. Term of Agreement**

This Agreement is valid for purchases through December 31, 2026.

### **5. Governing Law and Venue**

This Agreement is governed by the laws of the State of Illinois without regard to conflicts of law principals. Any action brought to enforce this Agreement must be brought in the state and/or federal courts located in Cook County, Illinois.

**6. Conflict**

In case of a conflict between any provision(s) of this Agreement and the Contractor's Bid or the Village's Request for Bids, this Agreement and the Village's Request for Bids shall control to the extent of such conflict.

**7. Dispute Resolution**

The Village does not agree to the mandatory arbitration of any dispute. In the event any action is brought to enforce this Agreement or to collect any unpaid amount from the Village, each party hereto shall bear the responsibility of paying its own attorney's fees and costs.

**8. Binding Authority**

The individuals executing this Agreement on behalf of the Parties represent that they have the legal power, right and actual authority to bind their respective party to the terms and conditions of this Agreement. A facsimile or pdf/email copy of this Agreement and any signatures thereon will be considered for all purposes as an original.

**THE PARTIES TO THIS AGREEMENT** by their signatures acknowledge they have read and understand this Agreement and intend to be bound by its terms.
