

RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT WITH SECURITAS SECURITY SERVICES USA, INC., IN AN AMOUNT NOT-TO-EXCEED \$819,000.00 FOR SECURITY AND SUPPORT STAFF SERVICES AT VILLAGE PARKING STRUCTURES AND NOT-TO-EXCEED \$78,000.00 FOR SECURITY AND SUPPORT STAFF SERVICES PROVIDED AT VILLAGE HALL FOR THE TERM OF NOVEMBER 1, 2023 THROUGH DECEMBER 31, 2024

THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT (hereinafter referred to as the “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and Securitas Security Services USA, Inc. (hereinafter the “Contractor”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated October 11, 2022 (“Agreement”); and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$819,000.00 for security and support staff services at Village parking structures and in an amount not to exceed \$78,000.00 for security and support staff services at Village Hall pursuant to the Contractor’s Proposal effective November 1, 2023, attached hereto and incorporated herein by reference.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement through December 31, 2024 pursuant to the Contractor’s Proposal effective November 1, 2023.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the parties as reflected below.
