A RESOLUTION APPROVING AN AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT WITH A & B LANDSCAPING, INC. FOR SNOW PLOWING AND SALTING OF VILLAGE LEASED/OWNED PARKING LOTS, BACK-UP SNOW REMOVAL FOR PUBLIC STREETS AND SIDEWALK SNOW SHOVELING FOR FISCAL YEAR 2021 TO CHANGE THE NOT TO EXCEED AMOUNT FROM \$175,000 TO \$250,000 IN 2021 AND AUTHORIZING ITS EXECUTION

BE IT RESOLVED by the President and Board of Trustees of the Village of Oak Park, Cook County, State of Illinois ("Village"), in the exercise of their home rule powers, that an Amendment to the Independent Contractor Agreement ("Amendment") with A & B Landscaping, Inc. to change the not to exceed amount from \$175,000 to \$250,000 for snow plowing and salting of Village leased/owned parking lots, back-up snow removal for public streets and sidewalk snow shoveling for fiscal year 2021 and the Village Manager is authorized to execute the Amendment in substantially the form attached.

THIS RESOLUTION shall be in full force and effect from and after its adoption and approval as provided by law.

AN AMENDMENT TO AN INDEPENDENT CONTRACTOR AGREEMENT BETWEEN THE VILLAGE OF OAK PARK AND A & B LANDSCAPING AND TREE SERVICE, INC. FOR SNOW PLOWING AND SALTING OF VILLAGE LEASED/OWNED PARKING LOTS, BACK-UP SNOW REMOVAL FOR PUBLIC STREETS AND SIDEWALK SNOW SHOVELING FOR FISCAL YEAR 2021 TO CHANGE THE NOT TO EXCEED AMOUNT FROM \$175,000.00 TO \$250,000.00

THIS AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT between the Village of Oak Park, an Illinois home rule municipal corporation, and A & B Landscaping and Tree Service, Inc., an Illinois corporation, is entered into this 1st day of March 2021 (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties entered into an Independent Contractor Agreement dated November 16, 2020 ("Agreement"); and

WHEREAS, the Parties seek to amend Section 2 of the Agreement pursuant to this Amendment to reflect a new total not to exceed amount of \$250,000.00.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

Contractor shall perform the Work for the Project in accordance with its Proposal for a price not to exceed ~~\$175,000~~ \$250,000 ("Contract Price"). Contractor shall complete the Work in accordance with any applicable manufacturers' warranties and in accordance with its Proposal, the Village's Request for Proposals, and this Contract, all of which, together shall constitute the "Contract Documents."

3. **OTHER PROVISIONS OF THE CONTRACT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.




