

**AN AMENDMENT TO AN AGREEMENT BETWEEN THE VILLAGE OF OAK PARK AND H&H  
ELECTRIC CO., INC. TO PROVIDE EMERGENCY STREET LIGHTING AND TRAFFIC CONTROL  
REPAIRS IN AN AMOUNT NOT TO EXCEED \$33,500.00**

**THIS AMENDMENT TO THE AGREEMENT DATED** January 31, 2017 between the Village of Oak Park, an Illinois home rule municipal corporation, and H&H Electric Co., an Illinois Corporation, is entered into this \_\_\_\_ day of July, 2017 (collectively referred to as the "Parties").

**RECITALS**

**WHEREAS**, the Parties entered into an Independent Contractor Agreement dated January 31, 2017 ("Agreement"); and

**WHEREAS**, the Parties entered into said Agreement for the calendar year of 2017 with an amount not to exceed \$25,000.00.

**WHEREAS**, the Parties seek to amend Section 2 of the Agreement pursuant to this Amendment to reflect a total amount of \$33,500.00.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

Contractor shall perform the Work for the Project in accordance with its Proposal for a price not to exceed ~~\$25,000.00~~ \$33,500.00 ("Contract Price").

3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
