WHEREAS, the Village is the owner of certain properties commonly known as 932-946 and 970 Madison Street, Oak Park, Illinois ("Property") and the Developer intends to conduct surveying and site topography work at the Property ("Work"); and

WHEREAS, in order to conduct such Work, it is necessary for the Developer to enter onto the Property, and the Village shall allow the Developer and its employees, representatives, agents, consultants and contractors to enter onto the Property and conduct the Work pursuant to the terms and conditions of this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter set forth, the parties agree as follows:

- 1. Recitals Incorporated. The above recitals are incorporated herein as though fully set forth.
- 2. Grant of Permission for Entry and Work. The Village grants the Developer, and its employees, representatives, agents, consultants and contractors, the right to enter the Property and conduct the Work set forth herein.
- 3. Term. - 4. Indemnification. The Developer shall indemnify, defend and hold the Village harmless from any and all claims, liabilities, damages, injuries and suits, known or unknown, arising out of or related to the entry upon the Property and any Work conducted at the Property by the Developer, and its employees, representatives, agents, consultants and contractors, notwithstanding and not limited by any insurance coverage. The Developer shall assume all potential liability for any injuries, deaths, losses, damages, claims or judgments of any nature resulting from or in connection with the Work, and the Village shall hold harmless, indemnify and defend the District against any such losses pursuant to this paragraph.
- 5. Insurance. The Developer shall obtain, maintain and provide to the Village, and shall cause any consultant or contractor entering the Property on behalf of the Developer to

obtain, maintain and provide to the Village, proof of comprehensive general liability insurance in the amount of at least \$1,000,000.00 combined, single limit coverage, naming the Village and its officers, officials, agents, volunteers and employees as additional insureds and with coverages reasonably satisfactory to the Village for the Work set forth herein.

- 6. Restoration of the Subject Property. The Developer, at its sole cost and expense, shall promptly repair any damage to the Property caused by the Work except as authorized herein.
- 7. Survival of Terms. Notwithstanding anything to the contrary contained in this Agreement, the terms, provisions, conditions and indemnifications of this Agreement shall survive the termination of this Agreement.
- 8. Work to Comply with Applicable Law. The Developer agrees that the Work it undertakes on the Property shall be in strict compliance with all applicable laws, statutes, codes, rules and regulations.
- 9. Work At Risk. The Developer acknowledges and agrees that the Work conducted by the Developer at the Property shall be fully at its own risk and the Village shall not be prejudiced in any way by the Developer's Work at the Subject Property.
- 10. Agreement at Village Request. The Developer acknowledges that it has requested this Agreement and shall fully comply with all of its terms.
- 11. Term. This Agreement shall be in full force and effect after its execution by the parties until completion of the Permitted Activities.
- 12. Enforcement of Agreement. The parties shall indemnify the other for any costs, including reasonable attorney's fees, which the other may incur in enforcing the provisions of this Agreement.
- 13. Release. Unless caused by either: (i) the negligent or willful acts or omissions of the Village, its agents, employees and other personnel; or (ii) any condition existing at the Property not caused by the Work: (A) the Developer forever releases and discharges the Village, its officers, officials, agents, volunteers and employees from all claims, demands, damages, actions, or causes of action, arising out of this Agreement or the Work pursuant to this Agreement; and (B) the Developer and its employees, representatives, agents, consultants and contractors, hereby covenant not to sue or otherwise bring any action in law or equity against the Village and its officers, officials, agents, volunteers and employees for any claims, loss, damage, expense, debt or liability of any nature whatsoever as a result of this Agreement or the Work pursuant to this Agreement.
- 14. Governing Law and Venue. This Agreement shall be governed by the laws of the State of Illinois. The provisions of this Agreement shall be enforceable in any action in law or in

chancery. The parties hereto agree that any legal action to enforce any right or obligation contained in or arising out of this Agreement shall be brought in the Circuit Court of Cook County, Illinois.

- 15. No Assignment. This Agreement shall not be assigned by any party hereto. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, devisees, personal representatives, and successors, except as otherwise provided herein.
