

## RESOLUTION

### A RESOLUTION APPROVING A PROGRAM YEAR (PY) 2024 SUBSTANTIAL AMENDMENT FOR COMMUNITY DEVELOPMENT BLOCK GRANT AND RELEASING THE DRAFT PY 2024 ACTION PLAN FOR PUBLIC COMMENT

**WHEREAS**, the Village of Oak Park is an entitlement community under the Housing and Community Development Act of 1974, as amended, and is therefore eligible to receive Community Development Block Grant (“CDBG”) funds from the United States Department of Housing and Urban Development (“HUD”) for each program year; and

**WHEREAS**, as a condition of grant funding, the Village has submitted its 2024 Action Plan to the U.S. Department of Housing and Urban Development (HUD) and received approval; and

**WHEREAS**, any subsequent substantial changes to the 2024 Action Plan are subject to a public comment period prior to submittal to HUD for inclusion in the Action Plan, the Village must undergo an in-depth citizen participation and review process during the development of this document; and

**WHEREAS**, the Village proposes changing the 2024 Action Plan to reallocate the funding from Department of Public Works to Neighborhood Services, Neighborhood Programs for lead waterline replacement.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees that the Village Manager or his designee is authorized to institute a 30-day public comment period on the proposed changes to the 2024 Action Plan, and, at the close of the 30-day comment period, the Village Manager is authorized to transmit an Amended Action Plan with a summary of comments to HUD as required by HUD regulations barring any changes to the Amended Action Plan during that period.

**THIS RESOLUTION** shall be in force and effect from and after its adoption and approval as provided by law.
