

**AN AMENDMENT TO A RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT WITH
SECURITAS SECURITY SERVICES USA, INC., TO INCREASE THE NOT-TO-EXCEED AMOUNT FOR
SECURITY AND SUPPORT STAFF SERVICES AT VILLAGE PARKING STRUCTURES FROM
\$717,031.00 TO \$800,000.00 FOR THE TERM OF
JANUARY 1, 2025 THROUGH DECEMBER 31, 2025**

THIS AMENDMENT TO THE RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT (hereinafter referred to as the "Amendment") is entered into this ____ day of June 2025, between the Village of Oak Park, an Illinois home rule municipal corporation, and Securitas Security Services USA, Inc. (hereinafter collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties entered into a Renewal of a Professional Services Agreement dated January 6, 2025 ("Renewal"); and

WHEREAS, the Parties seek to amend the Renewal to increase the not-to-exceed amount; and

WHEREAS, the Parties seek to amend Section 3 of the Agreement pursuant to this Amendment to increase the not-to-exceed amount;

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 3 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

The Village shall compensate the Contractor for the Services in an amount not to exceed ~~\$717,031.00~~ \$800,000.00 for services at Village parking structures and \$76,519.00 for services at Village Hall.

3. **OTHER PROVISIONS OF THE CONTRACT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
