

## ORDINANCE

### **AN ORDINANCE ESTABLISHING ALL-WAY STOPS AT THE INTERSECTION OF CLINTON AVENUE AND LEXINGTON STREET AND NORTHBOUND STOPS ON BELLEFORTE AVENUE AT GREENFIELD STREET AND FOREST AVENUE AT GREENFIELD STREET**

**WHEREAS**, the Village of Oak Park (“Village”) is a home rule unit of government as provided by the provisions of Article VII, Section 6 of the Illinois Constitution of 1970; and

**WHEREAS**, as a home rule unit of government, the Village is expressly empowered to perform any function pertaining to its government and affairs, including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare; and

**WHEREAS**, pursuant to the Illinois Municipal Code, Section 11-302 of the Illinois Vehicle Code, 625 ILCS 5/11-302, and Section 15-1-11 (“Stops Signs”) of the Oak Park Village Code, the Village is authorized to place and maintain stop signs upon highways under its jurisdiction in order to regulate, warn and guide traffic; and

**WHEREAS**, the Village has determined that the intersections of Lexington Street & Clinton Avenue, Belleforte Avenue and Greenfield Street, and Forest Avenue and Greenfield Street have become unsafe to vehicles and pedestrians approaching that intersection; and

**WHEREAS**, the Village has determined that it is necessary and reasonable and in the best interests of the citizens of the Village to authorize an all-way stop at the intersection of Lexington Street and Clinton Avenue for the reasons stated above; and

**WHEREAS**, the Village has determined that it is necessary and reasonable and in the best interests of the citizens of the Village to authorize that northbound traffic on Belleforte Avenue stop at the intersection of Greenfield Street and that northbound traffic on Forest Avenue stop at the intersection of Greenfield Street for the reasons stated above.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Recitals Incorporated.** The above recitals are incorporated herein by reference as though fully set forth.

**Section 2. Authorization to Post and Maintain Stop Signs.** The Village is hereby authorized to post and maintain stop signs for vehicular traffic traveling in all directions on Fillmore Street at its intersection with Euclid Avenue and with Wesley Avenue. The Director of the Department of Public Works, or his designee, is directed to install said stop signs and post and maintain any and all signs necessary to direct and inform motorists and pedestrians of the stop sign. The signs shall conform to the standards set forth in the State of Illinois Manual and

Specifications and shall be located as near as practicable to the nearest line of the crosswalk on the near side of the intersection.

**Section 3. Village Ordinance Establishing Traffic Control Signals Amended.** The Village's "Ordinance Establishing Traffic Control Signals," adopted pursuant to Chapter 15 ("Motor Vehicles and Traffic"), Article 1 ("In General"), Section 15-1-11 ("Stop Signs") of the Oak Park Village Code is hereby amended to include the following:

No person shall drive a motor vehicle northbound on Belleforte Avenue into the intersection of Greenfield Street without first bringing said vehicle to a full stop.

No person shall drive a motor vehicle northbound on Forest Avenue into the intersection of Greenfield Street without first bringing said vehicle to a full stop.

No person shall drive a motor vehicle on Lexington Street or on Clinton Avenue into the intersection of Lexington Street and Clinton Avenue without first bringing said vehicle to a full stop.

**Section 4. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 5. Effective Date.** This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
