

**EXTENSION OF A PROFESSIONAL SERVICES AGREEMENT AND SOFTWARE LICENSE AND  
SUPPORT AGREEMENT BETWEEN PASSPORT LABS, INC., A DIVISION OF  
PASSPORT PARKING, AND THE VILLAGE OF OAK PARK.**

**THIS EXTENSION OF THE PROFESSIONAL SERVICES AGREEMENT AND SOFTWARE LICENSE AND SUPPORT AGREEMENT** (hereinafter the “Extension”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the “Village”), and Passport Labs, Inc., a division of Passport Parking (hereinafter the “Contractor”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

**RECITALS**

**WHEREAS**, the Parties previously entered into a Professional Services Agreement and Software License and Support Agreement dated September 6, 2018 (“Agreement”); and

**WHEREAS**, the Parties seek to extend the Agreement for an additional 116-day period.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **EXTENSION OF AGREEMENT.** The Agreement between the Parties is hereby extended for an additional 116 days beginning on September 7, 2021 and ending on December 31, 2021 and shall be in full force and effect during said time period.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect from September 7, 2021 through December 31, 2021.
4. **EFFECTIVE DATE.** This Extension shall be effective as of September 7, 2021.
