The signed temporary license agreement must then go before the Village Board for consideration and approval.

CERTIFICATION

I, the undersigned, acknowledge that I have submitted both an application and certificate of insurance to the Village of Oak Park for the utilization of on-street public parking spaces for the 2024 season. I understand that the Village will place barricades in the street that will outline the dining area available to my restaurant. I understand that the same Village of Oak Park requirements in place for on-sidewalk outside dining apply to on-street outside dining and I agree to abide by these requirements and specifications, and further understand that failure to comply with these requirements may result in the revocation of my right to use said public parking spaces. I further understand that the cost to utilize each on-street public parking space is \$10 per day, six days per week and that I will be required to pay the Village for the use of the parking spaces I am intending to utilize in 2024, as outlined in the "Temporary License Agreement."

You are required to submit a Certificate of Liability Insurance with your application form. The

insurance requirements are as listed below.

- a. The Certificate of Liability Insurance you attach to your application form must provide evidence of a minimum of \$500,000 in general liability coverage. In addition, the Village of Oak Park, 123 Madison Street, Oak Park, IL 60302 should be listed as the certificate holder. The following language should be set forth in the "Description of Operations" section of the Certificate of Liability Insurance: The Village of Oak Park and its officials, officers, agents, employees and volunteers are named as Additional Insureds with respect to the public use of public parking spaces on (Name the street on which the parking spaces exist that you are utilizing), Oak Park, IL. Waiver of Subrogation applies to the Village of Oak Park and its officials, agents, employees and volunteers. Should any of the above described policies be canceled before the expiration date, the issuing company shall mail fifteen (15) days' written notice to the certificate holder named below.
