PROGRAM GRANTS: Committee members received all application and review materials two weeks prior to meeting. They each scored each application based on the selection criteria and additional criteria described in the program guidelines adopted by the Board of Trustees. Members reviewed confidential demographic information and program performance information in paper format before the meeting was called to order. After the meeting was called to order, members had the opportunity to review their scores and make changes. After some discussion, grant applicants were sorted in descending order of HPAC score. The committee decided to prioritize its recommendation by score, but also to adjust its final recommendation to spread funds more evenly by geography and building owner.
