

ORDINANCE

**AN ORDINANCE AMENDING SECTION 15-3-18 OF THE OAK PARK VILLAGE CODE
TO ESTABLISH A BUSINESS RESIDENTIAL PARKING PERMIT PROGRAM**

WHEREAS, the Village of Oak Park (“Village”) is a home rule unit of government as provided by the provisions of Article VII, Section 6 of the Illinois Constitution of 1970; and

WHEREAS, pursuant to the Village’s home rule authority and Section 11-71-8 of the Illinois Municipal Code, 65 ILCS 5/11-71-8, the Village may charge rates for its provision of parking facilities in the Village and the use thereof; and

WHEREAS, the President and Board of Trustees have determined to amend Section 15-3-18 as set forth in this Ordinance pursuant to the Village’s home rule authority and Section 1171-8 of the Illinois Municipal Code to establish a business residential parking permit program.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, County of Cook, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

Section 2. Village Code Amended. Chapter 15 (“Motor Vehicles and Traffic”), Article 3 (“Parking Meters, Parking Permits and Municipal Attendant Parking Lots”), Section 15-3-18 (“Parking Rates; Parking Meters, Pay by Space Machines, Village Operated Parking Structures, Permit, Extended Pass, Valet and Daytime On Street Parking”) of the Oak Park Village Code is amended by adding the underlined language to read as follows:

15-3-18: PARKING RATES; PARKING METERS, PAY BY SPACE MACHINES, VILLAGE OPERATED PARKING STRUCTURES, PERMIT, EXTENDED PASS, VALET AND DAYTIME ON STREET PERMIT PARKING:

Persons parking vehicles in Village owned and/or operated parking spaces designated by the Village for use by the general public as metered pay by space, Village operated parking structures, permit parking, extended pass parking, valet permit parking in designated areas during designated hours, shall pay a fee to the Village in accordance with the following rate schedule:

J. Daytime On Street Permit Parking Fee: Permit fees for all daytime on-street parking permits, other than parking permits for the disabled, issued for all daytime on-street permit parking areas authorized by ordinance of the President of the Board of Trustees shall be as follows:

Handicapped permits: Ten dollars (\$10.00) per year.

Resident permits: Seventy four dollars (\$74.00) per year.

Guest day passes; books of twenty (20): Five dollars (\$5.00) per book.

Business Residential Parking Permit Program: Any business licensed by the Village that provides services to residences in the Village shall be eligible for an annual business daytime on-street permit at a rate of hundred twenty four dollars (\$124.00) per year that may be used for up to five (5) vehicles, which includes business vehicles or private vehicles used by employees of the business. Said permit shall override all of the Village's street time limit restrictions except prohibited parking hours of 7:00 a.m. to 9:00 a.m. or 4:00 p.m. to 6:00 p.m., but shall not override any Village street cleaning restrictions, any Village safety-related restrictions, such as "no parking anytime" or a parking within a prohibited area because of a fire hydrant, or the Village's overnight parking prohibition. Said permit shall not be eligible for use in Village metered spaces, permit parking only spaces, or in a drop-off zone for persons with disabilities.

Employee permits where authorized by ordinance: One hundred twenty four dollars (\$124.00) per year.

Student permits:

If the Village administers permit sales:

Residents: Two hundred forty dollars (\$240.00) per year.

Nonresidents: Three hundred twenty dollars (\$320.00) per year.

The daytime permit parking rate for all students shall be two hundred forty dollars (\$240.00) per year if the school attended by the students purchases all student parking permits for students at that school for the full year prior to August 31 annually and the school agrees to administer the distribution of all such permits subject to the review of the Parking Services Manager.

Permits may be issued on a monthly or quarterly basis for an equivalent portion of the annual fee subject to the Village's discretion.

Fees which are not expended to cover the costs of administering the daytime, on street, permit parking program shall be deposited in a fund entitled the "Daytime Off Street Parking Fund", which shall be used exclusively for the provision of additional daytime, off street parking.

Any conflict between the provisions of this subsection and any other ordinance establishing

daytime on street permit parking in a specific area within the Village shall be resolved in favor of the other ordinance.

Section 3. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 4. Effective Date. This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
