RE: Emergency Water and Sewer Repair Contractor Agreements

The Department of Public Works Water and Sewer Division typically makes repairs to the water distribution and sewer collection systems with in-house staff. On the occasion when in-house staff is unavailable, for instance when crews are performing snow removal operations or lack the necessary equipment to perform such repairs or multiple repairs are required simultaneously. To avoid delays in making the emergency repairs, an outside water and sewer contractor is called in to make the repairs. The number of emergency repairs cannot be predicted; therefore it does vary from year to year.

A few weeks ago, the Water and Sewer Division requested rates for labor and equipment from area water and sewer contractors, for emergency repairs. Seven contractors responded to the request. Several contractors provided what appear to be reasonable and favorable rates. The work will be contracted on a job by job basis to make the needed repairs. The contractor with the most favorable prices will be contacted first and if they are not available, the next contractor will be contacted. Work will be paid for based on the Time and Material used method.

Funds for these services are budgeted in the FY Water and Sewer Fund, External Support, account no. 5040-43750-781-530667 (\$50,000.00 for Sewers) and 5040-43730-777-530667 (\$75,000.00 for Water) for a total of \$125,000.00.

Independent Contractor Agreements have been prepared for four contractors for emergency repair services on an as needed basis. It is proposed to enter into agreements with Concept Plumbing, Cerniglia Company and Trine Construction Company in the amount of \$25,000.00 each and with FJA Excavating for \$10,000.00.

Concept Plumbing is new to us but works for the Village of Schaumburg doing this work. FJA is also new to us and is a smaller company with limited municipal experience which is why it is recommended to go with a smaller amount.
