To Whom It May Concern:

The residents of the 300 South Harvey block (north of the east-west alley near Washington Blvd.) respectfully request restricted streets parking signs be installed on our block. We make the request in order to ensure we are able to receive the city services, which the Village provides for the well being of the residents of our community.

We find that workers are unable to provide critical services, such as leaf collection, snow plowing and street cleaning because of the number of cars parked on our street during the morning hours. The obstruction by parked cars during such services also hampers clear access for a handicapped resident on our block (designated by Handicapped Parking signs). These numerous cars do not belong to residents of the 300 block of S. Harvey (north of the alley) but rather to commuters, people who work/visit Madison Ave., residents of the 400 block of S. Harvey, and residents of Washington Blvd. The section of the street between Washington Blvd. and the alley is currently designated for those non-Harvey Ave. residents who have Village parking zone permits.

We are requesting the no-parking restrictions from **Monday - Saturday 8:00 AM-10:00AM.**
