

ORDINANCE
AN ORDINANCE AMENDING CHAPTER 15 ("MOTOR VEHICLES AND TRAFFIC"), ARTICLE 3 ("PARKING METERS, PARKING PERMITS, AND MUNICIPAL ATTENDANT PARKING LOTS"), SECTION 18 ("PARKING RATES; PARKING METERS, PAY BY SPACE MACHINES, VILLAGE OPERATED PARKING STRUCTURES, PERMIT, EXTENDED PASS, VALET AND DAYTIME ON STREET PERMIT PARKING") OF THE OAK PARK VILLAGE CODE TO REVISE THE VILLAGE'S EMPLOYEE DISCOUNT PARKING PROGRAM

BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Village Code Amended. Chapter 15 ("Motor Vehicles and Traffic"), Article 3 ("Parking Meters, Parking Permits, and Municipal Attendant Parking Lots"), Section 18 ("Parking Rates; Parking Meters, Pay by Space Machines, Village Operated Parking Structures, Permit, Extended Pass, Valet and Daytime On Street Permit Parking") of the Oak Park Village Code is amended by deleting the overstricken language and adding the underlined language as follows:

* * * * *

4. Reduced fee cards shall be sold to Oak Park employers for the benefit of their employees who work in Oak Park and earn an hourly wage of ~~\$20.00~~ \$21.80 per hour or less on a first come, first served basis. Effective January 1, 2026, and effective on the first of each subsequent year, this amount shall be increased by 3%. Reduced fee cards shall be sold on a quarterly basis and may be purchase by employers between the fifteenth day of the month preceding the start of the quarter and the fifth day of the first month of said quarter and the fifth of the following month on a first come, first serve basis. Once purchased reduced fee cards are nonrefundable.

6. Employee parking shall be available in the following lots:
- a. ~~Two hundred (200) spaces at the~~ Holley Court Garage at 1125 Ontario, ~~roof level only.~~
 - b. ~~One hundred and fifty (150) spaces at the~~ Avenue Garage at 720 North Boulevard, ~~roof level only.~~

7. The Development ~~Customer~~ Services Director or their designee shall establish the actual number of reduced fee cards that may be sold per quarter based upon utilization.

* * * * *

Section 2. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 3. Effective Date. This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
