

RESOLUTION

A RESOLUTION APPROVING AN AMENDMENT TO THE PROJECT BUDGET FOR THE EMERSON DEVELOPMENT TO INCLUDE THE COSTS FOR A WATER MAIN INSTALLATION IN THE AMOUNT OF \$88,000

WHEREAS, on May 27, 2014, the Village Board approved a Redevelopment Agreement with Clark Street Development for the development of the Oak Park Station (“Project”); and

WHEREAS, on November 3, 2014, the Village Board approved the First Amendment to the Redevelopment Agreement which added Lennar Multifamily Communities, LLC as a party to the Agreement; and

WHEREAS, on June 1, 2015, the Village Board approved the Second Amendment to the Redevelopment Agreement to finalize the project schedule completion; and

WHEREAS, on August 3, 2015, the Village Board approved the Third Amendment to the Redevelopment Agreement which removed 1118 Westgate from the original Redevelopment Agreement and approved a new Redevelopment Agreement for 1118 Westgate which allowed the Developer to start work on the partial demolition of 1118 Westgate in order for there to be space for the relocation of ComEd’s equipment located in the Village owned parking lot; and

WHEREAS, on October 19, 2015, the Board approved the Fourth Amendment to the Redevelopment Agreement that set the closing date for the sale of Village owned property on December 9, 2015; and

WHEREAS, on December 7, 2015, the Board approved the Fifth Amendment to the Redevelopment Agreement which extended the closing date to January 7, 2016; and

WHEREAS, on January 19, 2016, the Board approved an Amended and Restated Redevelopment Agreement for the Project; and

WHEREAS, on May 16, 2016, the Board approved the budget for the streetscape for the Project (“Project Budget”); and

WHEREAS, on November 7, 2016, the Board approved an Amendment to the Project Budget in the amount of \$232,615; and

WHEREAS, the Village Board approves an Amendment to the Project Budget in the amount of \$88,000 pursuant to this Resolution.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Oak Park, Cook County, State of Illinois, in the exercise of their home rule powers, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Resolution and shall have the same force and effect as though fully set forth herein.

Section 2. Project Budget Amendment. The Amendment to the Project Budget in the amount of \$88,000 is approved.

Section 3. Authorization to Execute Documents. The Village Manager is authorized to execute any and all necessary documents related to the Amendment of the Project Budget approved herein.

Section 4. Severability and Repeal of Inconsistent Ordinances, Resolutions and Motions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All resolutions, ordinances and motions in conflict herewith are repealed to the extent of such conflict.

Section 5. Effective Date. This Resolution shall take effect from and after its adoption and approval as provided by law.
