RESOLUTION

A RESOLUTION AUTHORIZING LOCAL FUNDING FOR THE FEDERALLY FUNDED PHASE I PRELIMINARY ENGINEERING DESIGN OF THE HOME AVENUE BRIDGE REPLACEMENT PROJECT, SECTION NUMBER 24-00269-00-BR

WHEREAS, the Village of Oak Park ("Village") is proposing to complete the Phase I preliminary design for the replacement of the Home Avenue pedestrian bridge over I-290 in the Village of Oak Park known as Section Number 24-00269-00-BR ("Project"); and

WHEREAS, the above stated improvement will necessitate the use of funding provided through the Illinois Department of Transportation (IDOT); and

WHEREAS, the use of these funds requires a joint funding agreement (AGREEMENT) with IDOT; and

WHEREAS, the improvement requires matching funds; and

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees Village of Oak Park, Cook County, State of Illinois, in the exercise of their home rule powers, that the Village hereby appropriates its share of the Project costs, which total Three Hundred Sixty Two Thousand Four Hundred Thirty Nine Dollars (\$362,439.00), or as much as may be needed to match the required funding to complete the proposed improvement from local Capital Improvement Funds and furthermore agree to pass a supplemental resolution if necessary to appropriate additional funds for completion of the Project; and

BE IT FURTHER RESOLVED that the Village Manager is hereby authorized to execute an AGREEMENT with IDOT; and

BE IT FURTHER RESOLVED This resolution will become Attachment 3 of the AGREEMENT; and

BE IT FURTHER RESOLVED that the Village Clerk is hereby directed to transmit three certified copies of the AGREEMENT and this Resolution to IDOT District One Bureau of Local Roads and Streets. the Illinois Department of Transportation through the Division of Transportation.

THIS RESOLUTION shall be in full force and effect from and after its adoption and approval as provided by law.
