VIOLA VEGA, WHO IS OUR FIRST YEAR DEBBIE CLERK, ON FRIDAY, JUNE 6, RISING FIFTH GRADER AND ENTHUSIASTIC STUDENT FROM WHITTIER PARTICIPATED IN THE JUNIOR DEPUTY CLERK PROGRAM AT THE VILLAGE HALL WITH A PASSION FOR MATH, READING, SKATING, SOCCER, SINGING, KEYBOARD, AND PUBLIC SPEAKING. A SOFT SPOT FOR JUNK FOOD. VIOLA BROUGHT A VIBRANT ENERGY AND CURIOSITY TO HER DAY IN LOCAL GOVERNMENT. DURING HER VISIT SHE LEARNED JUST HOW BIG VILLAGE HALL IS AND DISCOVERED HOW MANY DEDICATED PEOPLE WORK BEHIND THE SCENES TO KEEP OAK PARK RUNNING SMOOTHLY. VIOLA SHARED THAT SHE WISHED SHE HAD LEARNED HOW TO GET A JOB HERE HERSELF ONE DAY. A TESTAMENT TO HOW INSPIRED SHE WAS BY THE EXPERIENCE. FOR EXAMPLE, A DEGREE IN BUSINESS ADMINISTRATION WITH A CONCENTRATION IN MANAGEMENT IS A VALUABLE FOUNDATION FOR A CAREER IN A MUNICIPAL GOVERNMENT, HOWEVER, IT IS TRULY THE HANDS ON LIFELONG EXPERIENCE AND LOCAL GOVERNMENT THAT PREPARES ONE TO SERVE EFFECTIVELY AS VILLAGE CLERK. WHEN ASKED HOW THE JUNIOR DEPUTY - - JUST KEEP DOING WHAT YOU'RE DOING. HER PASSION FOR LEARNING AND CIVIC ENGAGEMENT REFLECTS THE PORTRAIT OF BROOKS MIDDLE SCHOOL. AS A FUTURE EIGHTH GRADER, SOPHIA IS ALREADY A CHANGE AGENT. SHOWING COMMITMENT TO MAKING A POSITIVE IMPACT LOCALLY AND GLOBALLY. ESPECIALLY THROUGH CIVIC INVOLVEMENT AND SUSTAINABILITY EFFORTS. IN ADDITION TO HER INVOLVEMENT IN THE JUNIOR DEBBIE CLERK PROGRAM, SOPHIA IS AN ACTIVE GIRL SCOUT AND ENJOYS MUSICAL THEATER. HER INTEREST AND ACTIONS SHOW THAT SHE IS WELL ON HER WAY TO BECOMING A THOUGHTFUL ENGAGED LEADER IN HER COMMUNITY. LAST AND CERTAINLY NOT LEAST, TATIANA VEGA. A RISING SOPHOMORE AT OPRF, WITH ASPIRATIONS OF BECOMING A LAWYER. DURING HER RECENT PARTICIPATION OF THE JUNIOR DEPUTY CLERK PROGRAM, SHE DISCOVERED THAT OAK PARK ADOPTED A VILLAGE MANAGER FORM OF GOVERNMENT IN THE 1950s TO PROMOTE A MORE EOUITABLE AND JUST COMMUNITY. I WILL TURN THIS OVER TO ASSISTANT VILLAGE MANAGER KIRA TCHANG TO REPORT ON THE ITEM, BUT BEFORE SHE GETS STARTED, THIS IS REALLY AN OUTCOME OF A REVIEW OF COMMUNITY RELATIONS COMMISSION WITH THE INPUT FROM PRESIDENT SCAMAN AND OUR LIAISON, AND THE CURRENT CHAIR OF THE COMMISSION TO RETTA.

I WANT TO SAY FROM THE OUTSET THAT THESE CONTEMPLATED CODE CHANGES REFLECTS OUR INTEREST IN TRYING TO FIND MODERN ALIGNMENT WITH THE CURRENT OPERATIONS OF COMMUNITY RELATIONS ACTIVITIES OUT OF THE DEI OFFICE, BUT ALSO ALIGNMENT WITH THE VISION FOR FUTURE OPERATIONS OF THE OFFICE.

THIS IS REALLY IMPORTANT BECAUSE AS YOU WILL SEE WITH THE CODE CHANGES, YOU WILL START TO SEE OPERATIONAL ACTIVITIES THAT YOU REVIEW IN THE NEAR FUTURE THAT MIGHT BE NEW AND DIFFERENT, BUT YET, STILL IN ALIGNMENT WITH THE UPDATED CODE CHANGES.

WITH THAT BACKGROUND I WILL TURN IT OVER TO KIRA, HOPEFULLY I DID NOT DUPLICATE ANYTHING YOU ARE GOING TO SAY.

I THINK THIS IS AN IMPORTANT ITEM FOR US TO PAY ATTENTION TO BECAUSE I THINK THERE'S A LOT OF THINGS THAT HAPPEN AFTER THIS.

>>KIRA TCHANG: GOOD EVENING TRUSTEES, PRESIDENT SCAMAN KIRA TCHANG, ASSISTANT VILLAGE MANAGER AND HR DIRECTOR. OF COURSE VILLAGE MANAGER JACKSON SHARED OUT INFORMATION REGARDING

THESE CHANGES.

FIRST AND FOREMOST I WANT TO SHARE THAT I HAVE HAD THE PRIVILEGE TO WORK WITH OUR STAFF IN IT DEI OVER THE PAST SEVERAL MONTHS AND TO PARTICIPATE IN A REALLY INTENTIONAL PROCESS WITH BOTH ELECTED OFFICIALS, STAFF, AND CHAIR TO RETTA TO DO SEVERAL THINGS. ONE IS MODERNIZING THE COMMUNITY RELATIONS COMMISSION'S ENABLING ORDINANCE.

TWO IS UPDATING THE COMMISSIONER PROFILE TO ENSURE THAT THE RIGHT FOLKS WITH THE RIGHT SKILLS ARE ABLE TO JOIN THAT COMMISSION. THREE IS LIKE MANAGER JACKSON MENTIONED, WORKING TO ALIGN THE BOARDS VISION FOR DEI WITH THE WORK THAT THE COMMISSION DOES THROUGH THE ENABLING LANGUAGE.

LIKE MANAGER JACKSON MENTIONED, ENSURING THAT THERE IS CLARITY FOR THE ROLES OF THE COMMISSIONERS VERSUS THE ROLES OF STAFF.

WHEN IT COMES TO DEI AND COMMUNITY RELATIONS ACTIVITIES.

THIS HAS BEEN A REALLY COMPREHENSIVE PROCESS THAT WE HAVE GONE THROUGH AND HAS LED TO SOME POSITIVE OUTCOMES AND CONVERSATIONS, THAT I THINK WELL HELP THE COMMUNITY RELATIONS COMMISSION REALLY SUCCEED MOVING FORWARD.

IN TERMS OF THE PROPOSED ORDINANCE LANGUAGE, I WANT TO HIGHLIGHT OR SUMMARIZE THE FIVE - WHAT I WOULD CALL THE FIVE CHANGES TO THE ORDINANCE.

ONE IS REALLY INTRODUCING AND INCLUDING THE CONCEPT OF EQUITY AND NOT JUST EQUALITY.

THAT WAS IMPORTANT, THE WAY WE TALK ABOUT THE COMMUNITY, THE WAY THAT WE TALK ABOUT WHAT IS NEEDED TO BRING OAK PARK TO WHERE OAK PARK WANTS TO BE.

THAT USE OF THE LANGUAGE OF EQUITY REALLY MODERNIZES THE WORK THAT THE CRC HAS BEEN DOING. THE SECOND IS BROADENING THE DEFINITION OF THE COMMUNITY BEYOND JUST RESIDENCE. SO WE KNOW THERE ARE PEOPLE WHO LIVE IN OAK PARK, OF COURSE, BUT THERE ARE PEOPLE THAT WORK HERE, THERE ARE PEOPLE THAT COME HERE TO VISIT AND ENJOY THE SPACE AND WE REALLY WANT TO ENSURE THAT THE WORK THAT IS BEING DONE BY THE COMMISSION REFLECTS THE NEEDS OF THE FULL COMMUNITY AND NOT JUST THOSE FOLKS THAT HAPPEN TO RESIDE WITHIN OAK PARK. THE THIRD PROPOSED ORDINANCE CHANGE RELATES TO INTERGROUP UNITY AND CULTURAL UNDERSTANDING. THAT IS SOMETHING THAT THE COMMISSION HAS ALWAYS HAD SOME STEAK AND, BUT HASN'T BEEN EXPLICITLY CALLED OUT WITH REGARD TO THE INTER AND INTRA COMMUNITY WORK. THAT REFLECTS ON A LOT OF THE WORK BEING DONE BY THE VILLAGE AT WILL. THE THIRD IS EXPLICITLY REFERENCING THE VILLAGES HUMAN RIGHTS ORDINANCE AS A MEANS FOR ENCOURAGING FAIR TREATMENT WITHIN THE COMMUNITY. ALL THAT WAS OR COULD BE ASSUMED IN THE PAST REALLY, ENSURING THAT THERE IS A COMMISSION AND ADVISORY BODY THAT PARTICIPATES IN THE HUMAN RIGHTS ORDINANCE ADMINISTRATION PROCESS WITH OUR STAFF, THAT WAS AN IMPORTANT CHANGE TO THE COMMISSION. LAST, BUT NOT LEAST IT ENHANCES THE CRC'S ROLE AND RESPONSIBILITY WITH REGARD TO COMMUNITY ENGAGEMENT. A GREAT DEAL OF COMMUNITY ENGAGEMENT HAPPENS BECAUSE OF THE COMPOSITION OF THE COMMISSION AND INTERESTS, BUT GIVING THE COMMISSION THE CLEAR MANDATE TO ENGAGE IN CONVERSATIONS THAT ARE IMPORTANT AND HAPPENING ACROSS THE COMMUNITY, PERHAPS FACILITATE SOME OF THE CHALLENGING CROSS-CULTURAL OR DIFFERENT HUMAN RIGHTS CONCERNS THAT GOES WITHIN THE COMMUNITY, THE ENABLING LANGUAGE CREATES THE SPACE FOR THE CRC TO BE ACTIVELY INVOLVED IN THE WORK. THOSE ARE THE SIGNIFICANT CHANGES. WE ALSO UPDATED THE PROFILE JUST A BIT TO CREATE CLARITY ABOUT THE COMMISSION, INCLUDING COMPETENCIES THAT WE THOUGHT WOULD BE VALUABLE WHEN IT COMES TO ENGAGING IN THE TYPE OF WORK THAT IS BEING PROPOSED IN THE ORDINANCE CHANGES. IN TERMS OF NEXT STEPS, THE CRC HAS BEEN WORKING ON AN UPDATED 2020 WORK PLAN. SHOULD THE BOARD ADOPT THE ORDINANCE CHANGES TONIGHT, WE WOULD BRING FORWARD A WORK PLAN THAT IS THE UPDATED STANDARDS TO THE NEXT POSSIBLE BOARD MEETING NEXT TUESDAY. SO THAT WOULD BE FORTHCOMING FOLLOWING YOUR DISCUSSION IF APPROVED TONIGHT.

AND I WANT TO SHARE, YOU KNOW, I'M HERE TO ANSWER ANY QUESTIONS, CHAIR TO RETTA WAS GRACIOUS ENOUGH TO JOIN US TONIGHT IF YOU HAVE QUESTIONS FOR HER AND WE ARE HERE SHOULD YOU NEED ANY CLARIFICATION.

>>PRESIDENT SCAMAN: KEIRA, I WANT TO COME, HOW THEY AGENDA ITEM HAS BEEN WRITTEN UP WITH THE HISTORY INVOLVED, BUT I WANT TO INVITE CHAIR YOKO, NOT LIKE TO THANK HER FOR THE PROCESS SHE HAS HELPED GUIDE US THROUGH, BUT TO BE ABLE TO SHARE ANY THOUGHTS AND BE AVAILABLE. THANK YOU BOTH FOR EVERYTHING.

YOKO, ANYTHING FURTHER YOU WOULD LIKE US TO DIGEST IN THIS?

>>PRESIDENT SCAMAN: DO YOU MIND SAYING IT UP HERE SO EVERYONE AT HOME HAS A BENEFIT OF HEARING YOUR WORDS? AND THAT THE NOISE.

>>SPEAKER: I WAS SAYING IT WAS A GREAT EXPENSE TO GET ALIGNED WITH LEADERSHIP IN THE VILLAGE AND MAKE SURE THE CRC HAS THE SPACE AND SUPPORT TO BE ABLE TO SUPPORT THE BOARD GOALS. APPRECIATE EVERYBODY'S TIME.

>>PRESIDENT SCAMAN: THANK YOU. ANY QUESTIONS OR FURTHER COMMENTS FROM THE BOARD? OPEN FOR DISCUSSION?

>> JUST AN EXPRESSION OF GRATITUDE FOR THE HARD WORK AND INTENTIONAL EFFORT AND TIME FOR YOUR SERVICE AND APPRECIATE IT. THANK YOU.

>>PRESIDENT SCAMAN: I ALSO WANT TO THANK TRUSTEE ENVIA AND CLERK WATERS FOR THEIR PARTICIPATION WITH ALL OF THEIR PASSION FOR OUR COMMUNITY IN ADVANCING US IN IT DEI AND BEING ABLE TO SERVE OUR RESIDENTS IN A VERY INTENTIONAL WAY SO THEY ALL HAVE WHAT THEY NEED TO LIVE AND THRIVE. AND THAT WE ARE ABLE TO LISTEN TO A BREADTH OF PERSPECTIVES AND LEARN FROM EACH OTHER AS WE GO. SO THANK YOU BOTH FOR YOUR LEADERSHIP AND KEVIN JACKSON. THEY WERE VERY REWARDING MEETINGS WE WERE PART OF. THIS IS NOT A QUICK PROCESS OR PARAGRAPH OR TWO CHANGES IN AN ORDINANCE, BUT A LOT OF DISCUSSION AND COMMITTED TIME TO BEING - JUST ALIGNING AS VILLAGE MANAGER JACKSON HAS ALREADY STATED - OUR INTENTION WITH THE EXPERTISE AND DESIRE OF OUR COMMUNITY AND HOW WE WORK TOGETHER. WE HAVE SOME EXTREMELY TALENTED PEOPLE THAT LIVE IN THIS VILLAGE. WE KNOW THAT, EVERY TIME WE TURN AROUND WE RUN INTO SOMEBODY THAT IS TRULY AT THE TOP OF THEIR FIELD IN ALL KINDS OF SERVICES. THIS IS A GREAT MOMENT AND I AM REALLY LOOKING FORWARD TO WHAT COMES NEXT. WITH THAT WE WILL NOT PROLONG THE EVENING. THE WORK IS STILL TO COME.

>>PRESIDENT SCAMAN: I APPRECIATE YOU ALWAYS - AND FOR JOINING US ON A NIGHT LIKE TONIGHT.

SO WE DO HAVE CALLED TO BOARD AND CLERK.

IF I CANNOT START OFF AND CLOSE, WE OFTEN HAVE PROCLAMATIONS IN OUR BOARD AGENDAS AND WE WILL PROPERLY HAVE A JUNETEENTH PROCLAMATION NEXT WEEK.

AS WE HAVE BEEN DOING, I THINK THIS MIGHT BE OUR FIFTH YEAR IN COMMUNITY TO CELEBRATE JUNETEENTH, BUT WE HAVE A NUMBER OF EVENTS THIS WEEKEND BEFORE THE PROCLAMATION IS TO BE READ.

WITH THAT IN MIND WE WANT TO REFLECT ON WHAT IT MEANS TO CELEBRATE JUNETEENTH.

JUNE 19, 1865, UNION MAJOR GENERAL GORDON GRANGER ARRIVED IN GALVESTON TEXAS WITH A MESSAGE TO CHANGE LIVES.

THE CIVIL WAR HAD ENDED AND ENSLAVED PEOPLE WERE FINALLY FREE. THIS NEWS CAME 2 1/2 YEARS AFTER PRESIDENT LINCOLN HAD ISSUED THE EMANCIPATION PROCLAMATION.

TEXAS WAS THE LAST STATE TO RECEIVE AND ENFORCE THE MESSAGE. AS THE NEWS SPREAD, MANY NEWLY FREED PEOPLE LEFT PLANTATIONS DETERMINED TO FIND FAMILY AND BUILD NEW LIVES IN STATES LIKE LOUISIANA, ARKANSAS AND OKLAHOMA.

FREEDOM CAME WITH DEEP CHALLENGES.

PROMISED LAND AND SUPPORT WERE STRIPPED AWAY BY POLICIES THAT FAVORED THE VERY PEOPLE THAT HAD FOUGHT TO PRESERVE SLAVERY.

STILL THAT DAY IN JUNE BECAME A TURNING POINT.

IT GAVE RISE TO A CELEBRATION.

JUNETEENTH, A TIME TO COME TOGETHER, PRAY, REFLECT AND RETURN TO GALVESTON.

IT WAS A MOMENT TO REMEMBER FREEDOM AND REMIND EACH OTHER THAT PROGRESS WAS POSSIBLE, EVEN IN THE FACE OF INJUSTICE. TODAY, JUNETEENTH IS MORE THAN A CELEBRATION OF EMANCIPATION. IT HONORS BLACK ACHIEVEMENT, RESILIENCE AND COMMUNITY. IT ALSO CHALLENGES US TO CONFRONT THEIR LEGACY OF RACISM THAT CONTINUES TO IMPACT EVERY PART OF AMERICAN LIFE. THE FIGHT FOR EQUITY AND JUSTICE DID NOT END IN 1865 AND IT CONTINUES TODAY. THIS DAY ALSO HONORS LEADERS LIKE OPAL LEE, OFTEN CALLED THE GRANDMOTHER OF JUNETEENTH, WHOSE TIRELESS ADVOCACY MADE JUNETEENTH A FEDERALLY RECOGNIZED HOLIDAY. HER WORK SHOWS US HOW ONE VOICE, ONE LIFE CAN HELP SHAPE HISTORY. ON JUNETEENTH WE REFLECT, WE CELEBRATE FREEDOM, WE HONOR THE PAST AND COMMIT TO BUILDING A MORE JUST FUTURE TOGETHER. WE INVITE THE COMMUNITY TO CELEBRATE THIS WEDNESDAY EVENING IN OUR COURTYARD FOR THE FLAG RAISING CEREMONY. AND THERE WILL BE LIVE PERFORMANCES AND SPECIAL GUESTS, INCLUDING SAXOPHONIST KENNY WILLIAMS, AFRICAN DRUMMING, BLACK NATIONAL ANTHEM AND - - JUBILEE SPEAKERS, SA AWARDEES. WE THEN CELEBRATE TOGETHER ON A JUNE 14 ALSO AT THE VILLAGE HALL, BUT ON THE SOUTH LAWN FROM 11-3 PM WITH A COOKOUT AND A CELEBRATION. ALL ARE INVITED AND LOOKING TO REALLY CELEBRATE IN COMMUNITY. I ALSO WANT TO THANK ALL OF THE COMMUNITY MEMBERS AND OUR DEI STAFF WHO HAVE WORKED TOGETHER TO ORGANIZE BOTH OF THESE EVENTS. THIS IS ALSO REMINDING ME THAT WITH THE PREVIOUS AGENDA ITEM THERE ARE MANY VOLUNTEERS THAT CAME BEFORE THOSE OF US SITTING AT THE BOARD TABLE TODAY AND WERE PART OF THE COMMUNITY RELATIONS COMMISSION OF THE PAST. GOING BACK GENERATIONS, BUT ALSO IN RECENT HISTORY. ALL OF THEIR WORK IS WHAT WE LOOK TO BUILD UPON AND HONOR AND RESPECT THE COMMITMENT AND TALENTS OF THOSE WHO CAME BEFORE US IN THIS WORK. THANK YOU. IN FACT, SOME OF THE WORDS THAT I JUST READ WERE TAKEN FROM THE PROCLAMATION THAT JUANTA GRIFFIN HELPED PROPOSED IN A 2021. OR 2020. SO NOW IF WE CAN PROCEED WITH CALL TO BOARD AND CLERK? CLERK WATERS? >>CLERK: PASS. >>TRUSTEE ENYIA: LIKE YOU SAID EARLIER, IF YOU HAVE AN OPPORTUNITY OVER THE WEEKEND TO JOIN FOR THE BARBECUE, BUT ALSO TOMORROW EVENING, 6-8. THE FLAG RAISING HERE AT VILLAGE HALL. DEFINITELY SOMETHING TO GET OUT AND SEE, ESPECIALLY SEEING WHAT WE SEE IN OUR COUNTRY. I WHOLEHEARTEDLY HOPE TO SEE YOU ALL THERE. AND SENDING A HUGE SHOUT OUT TO MY DAD TOMORROW. HIS 80TH BIRTHDAY. >>PRESIDENT SCAMAN: A HAPPY BIRTHDAY.

>> I WANTED TO CONGRATULATE OAK PARK YOUTH BASEBALL AND SOFTBALL ON ANOTHER SUCCESSFUL SEASON. EACH OF THE DIVISIONS EITHER WRAPPED UP THIS PAST WEEKEND OR IS WRAPPING UP THIS LAST WEEK. THEY HAVE FOUR YEARS NOW BUT TOGETHER. WONDERFUL REC LEAGUE, BASEBALL AND SOFTBALL HERE IN OUR COMMUNITY. MORE THAN 1000 KIDS PARTICIPATE EVERY YEAR. THIS IS A TOWN THAT LOVES BASEBALL AND THEY MAKE IT OPEN AND ACCESSIBLE FOR ALL OF OUR KIDS TO HAVE AN OPPORTUNITY TO PARTICIPATE IN BASEBALL AND SOFTBALL. HUGE SHOUT OUT AND CONGRATULATIONS TO THEM ON ANOTHER SUCCESSFUL SEASON. >>PRESIDENT SCAMAN: CONGRATULATIONS. >>TRUSTEE ENVIA: CAN I SAY ONE THING? CONGRATULATIONS TO HOPE IN THE ELMO FOR THE WIN YESTERDAY. >> I WOULD LIKE TO CONGRATULATE MY CONGRATULATIONS TO CHRISTINA WATERS FOR HER EFFORT AND ORGANIZING OF THE JR DEPUTY CLERK PROGRAM.
