

RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE VILLAGE OF OAK PARK INDUSTRIAL/ORGANIZATIONAL SOLUTIONS, INC AND AUTHORIZING ITS EXECUTION

THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT DATED JULY 29, 2019 (hereinafter referred to as the "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the "Village"), and Industrial/Organizational Solutions, Inc., an Illinois corporation (hereinafter referred to as the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated July 29, 2019 (hereinafter referred to as the "Agreement") for the Contractor to provide testing and assessment services for entry level firefighter and police officer positions and fire and police promotional positional ranks; and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of Section 4 of the Agreement for an additional two (2) year term ending on January 19, 2022 at 11:59 p.m. subject to the rates set forth in Exhibit A attached hereto and incorporated herein by reference.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
