

**EXTRACT OF MINUTES** of a regular public meeting of the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, held at the Village Hall, in said Village, at 273 Madison Street, Oak Park, Illinois 60302, on the 3rd day of September, 2019.

The President called the meeting to order and directed the Village Clerk to call the roll.

The President and Board of Trustees then gave a public recital of the nature and purpose of the ordinance, which included a reading of the title aloud and an explanation that the ordinance authorizes the Village to enter into a Business Incentives Agreement (the “**Business Incentives Agreement**”), by and between the Village of Oak Park, Cook County, Illinois, an Illinois municipal corporation and home-rule unit, and CMV Development LLC, an Illinois limited liability company.

The President declared the motion carried, and upon further discussion, Trustee \_\_\_\_\_ presented to the Village Clerk the following ordinance, which was read to the Village Board as follows:

**AN ORDINANCE** Approving a Business Incentives Agreement between the Village of Oak Park and CMV Development LLC (“CMV”) to Provide Financial Incentives in the Amount of \$50,000 to Complete two Development Projects Located at 6555 and 6545 North Avenue Consistent with the Oak Park Economic Development Corporation’s (Oak Park EDC) Recommendation and Authorizing Its Execution

**WHEREAS**, the Village of Oak Park, Cook County, Illinois (the “**Village**”), a home rule unit of government has heretofore considered the potential for development and redevelopment of 6555 North Avenue and 6545 North Avenue in the Village; and

**WHEREAS**, the President and Board of Trustees of the Village (the “**Corporate Authorities**”) have heretofore, and it hereby is, determined that it is in the best interests of the Village that a Business Incentives Agreement (the “**Business Incentives Agreement**”) specifically pertaining to 6555 North Avenue and 6545 North Avenue, be executed by the Village; and

**WHEREAS**, the Corporate Authorities have heretofore, and it hereby is, determined that the proposal of CMV Development LLC, an Illinois limited liability company (the “**Developer**”), for the development of (i) 6555 North Avenue as a mixed use project, including ten (10) apartments, along with 2,000 square feet of ground level commercial space (the “**Mixed Use Project**”) and (ii) 6545 North Avenue as a residential project to include fifteen (15) apartments (the “**Residential Project**”) is in the best interests of the Village, that the Developer be the exclusive Developer for the Mixed Use Project and Residential Project as described therein and that the proposed Business Incentives Agreement by and between the Village and the Developer be executed; and

**WHEREAS**, the Business Incentives Agreement is on file and available to the general public in the office of the Village Clerk:

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, as follows:

**Section 1. Recitals Incorporated.** The preambles hereto be, and the same hereby are, incorporated herein by this reference as if set out in this section in full.

**Section 2. Business Incentives Agreement Approved.** The Business Incentives Agreement, in substantially the form presented to the President and Board of Trustees at this meeting and attached hereto as Exhibit A, and the same hereby is, approved, and the Village Manager and Village Clerk are hereby authorized and direct to execute the same, with such additions, completions, omissions, insertions or revisions as they shall, in their sole discretion and without further official action of the Corporate Authorities, determine.

**Section 3. Repealer.** That all Ordinances or parts of Ordinances in conflict herewith are expressly repealed.

**Section 4. Savings Clause.** That in the event any portion of this Ordinance is declared to be void, that such other parts or remainder of this Ordinance shall not be adversely affected and shall otherwise remain effective and valid.

**Section 5. Publication of Ordinance.** A full, true and complete copy of this Ordinance shall be published within ten (10) days after passage in pamphlet form by authority of the Corporate Authorities.

**Section 6. Adoption Clause.** That this Ordinance shall be in full force and effect from and after its approval, adoption and publication as required by law.
