

## RESOLUTION

### **A RESOLUTION APPROVING THE PROGRAM YEAR 2015-2019 CONSOLIDATED PLAN AND THE PROGRAM YEAR 2015 ACTION PLAN FOR SUBMITTAL TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT**

**WHEREAS**, the Village of Oak Park ("Village") is an entitlement community under the Housing and Community Development Act of 1974, as amended, and is therefore eligible to receive community development block grant ("CDBG") and emergency solutions grant ("ESG") funds from the U.S. Department of Housing and Urban Development ("HUD") for each program year; and

**WHEREAS**, in order to receive these grant funds each year, the Village must submit a Consolidated Plan for Housing and Community Development ("Con Plan") to HUD every five years, this document being due August 14, 2015; and

**WHEREAS**, in order to receive these grant funds for PY 2015, the Village must submit a PY 2015 Action Plan also due August 14, 2015; and

**WHEREAS**, as required by HUD Con Plan regulations, the Village had an in-depth citizen participation and review process during the development of the above referenced documents, with both plans being released for a 30 day comment period and no comments were received by the Village.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Oak Park, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Recitals Incorporated.** The recitals set forth above are incorporated herein as though fully set forth.

**Section 2. Con Plan and PY 2015 Action Plan Approved.** The Con Plan and the PY 2015 Action Plan are approved and the Village Manager is authorized to transmit the documents and any subsequent amendments to HUD.

**Section 3. Severability and Repeal of Inconsistent Ordinances, Resolutions and Motions.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this resolution. All ordinances, resolutions or adopted motions in conflict herewith are hereby repealed to the extent of such conflict.

**Section 4. Effective Date.** This Resolution shall be in full force and effect immediately after its passage as provided by law.
