#### Village Board Meeting

On Monday, June 1, starting at 6:30 p.m. the Village Board will hold two sequential meetings via a Remote Participation.

First, an Emergency Meeting via Remote Participation has been publicly noticed per ILCS 120/2.02 and this meeting was noticed at approximately 5 p.m. today. This meeting was requested to consider a single item, Village Board approval of an ordinance to authorize the Mayor/Village President to declare a local state of emergency and order a temporary curfew as part of a declaration through June 8, 2020.

There were more than thirty nine residential properties tagged with graffiti and six cars. A final count is in process. Public Works staff worked throughout the day with Community Relations staff and police officer on assisting property owners with clean up and graffiti removal.

At the request of Acting Chief of Police Joe Moran, a curfew beginning at 9 p.m. this evening is being sought.

The Police Department is working with the Illinois Law Enforcement Alarm System (ILEAS) which was formed in 2002 in response to the September 11th attacks as a joint venture of the Illinois Association of Chiefs of Police, the Illinois Sheriffs' Association, and the Illinois Emergency Management Agency for additional resources related to the high rate of criminal activity which occurred beginning on May 31, 2020 targeting local Oak Park businesses and extensive graffiti focused on residential areas. ILEAS is established pursuant to the Constitution of the State of Illinois (Ill. Const. Art. VII, sec. 10), the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1 et seq.), the Local Governmental and Governmental Employees Tort Immunity Act (745 ILCS 10/7-101 et seq.) and the Illinois Municipal Code (65 ILCS 5/11-1-2.1).

The second Village Board meeting to be conducted immediately following the Emergency Meeting and was publicly noticed on Thursday, May 28, at the close of business.

Both meetings will be conducted with live audio available and optional video of the Village Officials. The meeting will be streamed live and archived online for on-demand viewing at [www.oak-park.us/boardtv](http://www.oak-park.us/boardtv) as well as cablecast on VOP-TV, which is available to Comcast subscribers on channel 6 and ATT Uverse subscribers on channel 99. Remote Meetings of the Oak Park Village Board of Trustees is authorized pursuant to Section 6 of Governor J.B. Pritzker's Executive Order 2020-07 as extended by Executive Order 2020-39.

#### **Expiration of Declaration of an Emergency Affecting Public Health**

On Monday, June 1, the Village of Oak Park's Declaration of an Emergency affecting Public Health as a result of the COVID-19 pandemic expired. The Declaration was enacted via the following actions of the Village Board:

March 13, 2020	Resolution 20-120
April 6, 2020	Resolution 20-124
May 4, 2020	Resolution 20-128

Through November 15, 2020, via Ordinance 20-041 the Village of Oak Park Public Health Director may continue to make such reasonable rules, regulations and orders as may from time to time be deemed necessary due to the outbreak of COVID-19 disease in the State of Illinois.

#### **New Declaration of Local State of Emergency**

On Sunday May 31, and again Monday June 1, and today, June 2, 2020, through action of the Mayor and subsequently authority of the Village Board, a curfew has been instituted from 9 p.m. to 6 a.m. due to a local state of emergency and in response a high number of nightly criminal property damage at local businesses. Graffiti has also been experienced on residential properties and cars.

### **Suspension of Curfew**

Based upon recommendation of Acting Chief Moran, the Mayor did not issue an additional overnight curfew for Wednesday June 3. During last night's curfew, Tuesday June 2nd into this morning, our neighboring communities of Cicero and Berwyn closed off all street traffic along Roosevelt Road due to a protest on Cermak Road around 6 pm. In Oak Park, the following businesses experienced criminal property damage:

In addition, in the 300 block of N. Lombard a ruse burglary occurred when offenders posed as utility workers. At an apartment building at 508 N. Cuyler it was reported that three projectiles impacted the apartment building, and police recovered a casing found in street.

### **Interim Deputy Fire Chief Infectious Disease**

The appointment of Joseph Terry as Interim Deputy Fire Chief for Infectious Disease has been extended through July 31, 2020. The initial appointment was made March 13 following a Side Letter agreement with the IAFF Local 95 to address issues related to wages, benefits and the Fire Fighters Promotional Act which is a state law governing the competition promotional process for all fire fighters under the rank of Deputy Chief. Interim DC Terry has been working with the Public Health Director with a focus on senior long term care facilities and other matters related to the Village's response to COVID-19.

### **Management Council & Council of Governments (COG)**

This week, meetings of both the Management Council and COG were held as part of the continuing dialogue amongst the organizations about efforts in Phase 3 of Restore Illinois as well as public safety matters related to the civil unrest in response to the murder of George Floyd in Minneapolis.


### **Virtual A Day in Our Village Celebration 2020**

### **Personal Protective Equipment (PPE)**

As noted early in the week, the Oak Park Public Health Department, as a Certified Public Health Department, has received a shipment of PPE from the Illinois Emergency Management Agency (IEMA). The items have been inventoried and allotted to the Village's public health and public safety needs, which are inclusive of supporting the Farmers Market and preparing for the Early Voting process which will occur this Fall. As part of the Village's response to the COVID-19 pandemic, through today the Village delivered masks to 93 restaurants, a total of 4,400 surgical masks. Grocery stores and additional retailers will be delivered masks next week. The PPE is intended to provide businesses with a small supply in the event the encounter delivery delays of PPE through the open market.

Also, through the Village's public health supplies, today the Oak Park Public Health staff is also able to provide masks to residents testing positive for COVID-19 and Oak Park close-contacts.

Arrangements are made as part of the contact tracing done by the Public Health staff.

## Village to cablecast virtual OPRF High School graduation

A special thank you to Village Communications staff that are going the extra step to be part of the Oak Park River Forest High School seniors walk across the virtual YouTube stage to accept their diplomas over the weekend. ### Phase 4 Preparations

Public Health Director Mike Charley announced that the State of Illinois has communicated that all regions of the State, including Oak Park are in position to move to Phase 4 of the Restore Illinois Plan on Friday, June 26, 2020.

Moving to Phase 4 will allow more activity at Oak Park businesses. Director Charley has shared via email with all Oak Park business license holders the anticipated move to Phase 4 and affirmed that it is the mission of the Village is to get people back to work with as much normalcy as possible without jeopardizing the health and safety of Oak Park residents, visitors and employees.

Additionally, Director Charley shared what is known today regarding the State's Restore Illinois plan and the changes anticipated when moving to Phase 4:

- **Bars and Restaurants:** May open for indoor seating with state-specific capacity limits & IDPH approved safety guidance\*.
- **Cinema and Theaters:** May open following IDPH approved safety guidance\*.

- **Childcare:** DCFS licensed childcare facilities can remain open while following DCFS and Illinois State safety guidance\*.
- **Health Clubs:** Health clubs, gyms, and fitness studios will be allowed to reopen following IDPH approved safety guidance\*.
- **Retail:** All retail stores can remain open to in-person shopping with state-specific capacity limits & IDPH approved safety guidance\*.
- **Personal Care Services** Personal care services, like nail salons, tattoo shops, hair braiders, spas and barbershops, can remain open with IDPH approved safety guidance\*.
- **Manufacturing:** All manufacturing can remain open with IDPH approved safety guidance\*.
- **“Non-essential” businesses:** Same as phase 3. Employees of “non-essential” businesses are allowed to return to work with IDPH approved safety guidance. Employers are encouraged to provide accommodations for COVID-19-vulnerable employees.
- **Gatherings:** Gatherings of 50 or fewer will be allowed, but are subject to change based on latest data and Illinois-state guidance.
- **Outdoor Recreation:** All outdoor recreation will be allowed.

\*Prior to June 26, the [Illinois Department of Commerce and Economic Opportunity](#) (IDCE) will be releasing COVID-19 Restore Illinois phase 4 Guidelines for different types of workplaces/business that should help answer specific questions workplaces and businesses have regarding the transition from Phase 3 to Phase 4 of Restore Illinois. The Village will share information and State links to the information when it is released by the State.

Director Charley notes that the Illinois Department of Commerce and Economic Opportunity (IDCE) COVID-19 Phase 4 Guidelines will address:

- **General health requirements:** Employers must have plans for social distancing, working from home, handwashing.
- **HR & travel policies:** All employees must complete health & safety training related to COVID-19 prior to returning to work. Limiting all essential travel.
- **Health monitoring:** Employers should conduct temperature screenings and follow state guidance regarding sick employees.
- **Physical workplace:** Social distancing signage, proper space configuration of employees, removing shared items, providing hand sanitizer and environmental cleaning.
- **Customer behaviors:** For some businesses, reservations will be required, cloth face coverings required, customers that are COVID-19 symptomatic cannot be allowed entry, maintain social distancing.
- **Capacity limits:** For specific business types, the State will specify capacity limits based on occupancy and/or square footage.

### Village Employee Tests Positive

Late yesterday, the Village received notification that a Village employee has tested positive for COVID-19. This is the seventh Village employee. In compliance with the Village's safety protocols and provisions already in place for COVID-19 positive diagnoses in the workforce, this employee and any other employees who have had direct close contact with this individual, have been notified and placed in quarantine status. The Village has initiated cleaning protocols for any and all spaces identified as higher risk. This employee is a sworn firefighter working in the Fire Department. Because of privacy laws, no additional information can be released.

### Lake Street Construction Update

With the recent opening of the intersection of Lake and Oak Park Avenue, as well as the installation of parklets on Lake Street for restaurants between Oak Park Avenue and Euclid, the Village Engineer has reached out to the Hemingway Business District to discuss the schedule for the remainder of the project improvement in the area on Lake Street in order to determine if the District would request any potential schedule changes for review by the Village Board on July 6, 2020. Public Works is currently working with the Lake Street contractor on detailed schedules

which are anticipated to require about twelve weeks of addition work on the Lake Street project from Oak Park to Euclid (much of the work will require closing Lake Street between Oak Park Ave Euclid). Traffic on Oak Park Ave would remain open, except during a “to be determined” time period for brick installation in the intersection at Lake and Oak Park. The Hemingway Business District is being asked to comment on the following options:

- Option 1: No construction delay. The construction work would be starting very soon, possibly early-mid July with electrical at the Oak Park Ave intersection for temporary traffic signals which would reduce some outdoor dining spaces. Significant work would start roughly August 1st with removing curbs and sidewalks. This would trigger the road closure, partial sidewalk closure in area behind curb, and no more outdoor dining (except for Fairgrounds). Possible finish mid to late October.
- Option 2: Delay construction until September, immediately after Labor Day to allow restaurants on Lake St to have the summer with work completed early December.
- Option 3: Delay construction till spring of 2021 to allow more time for business recovery. Work would likely start in mid to late March of 2021 with work completed in June 2021.

In regards to Lake Street from Harlem to Forest, construction remains on schedule with a re-open set for the week of August 7.

Work on Lake Street east of Euclid to Austin is ahead of schedule. All pavement milling is complete and repair of the base is underway which will allow for re-paving to occur in early July.

## **Village Hall Operations**

Village Hall is set to reopen to the public Monday with the focus on keeping visitors and municipal employees safe from the COVID-19 coronavirus by limiting building hours and occupancy. Open Monday – Thursday, hours will be limited from 9 a.m. to 10 a.m. for senior citizens and individuals at higher risk for contracting the virus and from 10 a.m. – 5 p.m. for all others. Fridays will be appointment only days.

The public is reminded they may also call 708.358.5700 from 7:30 a.m. to 4 p.m. weekdays to seek assistance as all services continue to be available online at [www.oak-park.us/onlineservices](http://www.oak-park.us/onlineservices) and can be done fast and efficiently without a trip to Village Hall.

Everyone entering the building will be required to wear a mask covering their nose and mouth. Disposable masks will be provided for use inside Village Hall for anyone over the age of 2 who does not have one. In order to comply with social distancing requirements, the Village Hall lobby has been reconfigured and counters with clear glass “sneeze guards” have been arranged to ensure the health and safety of customers and municipal staff while the risk of community spread of COVID 19 remains. The lobby can accommodate a maximum of eight persons at a one time and additional visitors will be assisted in order as service counter space opens. A staff member will be working in the lobby to facilitate the proper municipal worker is available to provide the various customer services available at Village Hall.

Providing in-person services that are safe is a priority while the numbers of COVID-19 cases appear to have stabilized in Oak Park, the risk of community spread is a reality that informs delivering services in the most effective and safest ways possible. As such, online services remain highly recommended.
