Description of Work

Name: Resurfacing of Various Streets and Parking Lots

Location: Various Streets in Oak Park IL

Proposed Improvement: In general, the improvements consist of the removal and replacement of curb and gutter, sidewalks, ADA ramps, driveways, drainage structure adjustments, pavement patching, cold-milling of bituminous concrete, installation of hot-mix asphalt binder and surface courses, pavement striping, parkway restoration, and all appurtenant work thereto.

Bidders Instructions

- Plans and proposal forms will be available in the Office of the Village Engineer, 201 South Boulevard, Oak Park, Illinois 60302 upon payment of <u>\$40.00</u> (non-refundable). No plans will be issued to prospective bidders after 4 P.M. on the working day preceding the opening of bids. Proposals will not be accepted by the Village of Oak Park from Contractors who have failed to provide payment, if required, for obtaining proposal forms and have also failed to register with the Engineering Division of the Public Works Department as plan holders for this project.
- At the bid opening, all proposals <u>must</u> be accompanied by a proposal guaranty in the amount of 5% of the bid amount. The proposal guaranty shall be in the form of a bid bond executed by a corporate surety company or a bank cashier's check.

- 3. The awarding authority reserves the right to waive technicalities and to reject any or all proposals as provided in Article 102.01 of the 2016 "Standard Specifications for Road and Bridge Construction," prepared by the Illinois Department of Transportation.
- The work to be performed pursuant to this Proposal is subject to the Illinois Prevailing Wage Act, 820 ILCS 130/0.01 et seq.


