SUBJECT: Pedestrian (Field) Stop Data – 2024 Second Quarter

---

## Purpose

The purpose of this memorandum is to provide data on the pedestrian/field stops for the second quarter (April-June) of 2024. The significant increase in pedestrian/field stops is largely due to the number of newly hired officers in the field training program.

## Background

There were at total of 66 field stops: 59 were Calls for Service (CFS) and seven were Self-Initiated Stops (SI), resulting in five arrests. Below is the summary of data for each month and attached is a [PowerPoint](#) with the details of each stop.

In **April**, there were 26 pedestrian stops in response to 17 incidents, the result of multiple individuals stopped for one CFS and two arrests (Retail Theft and Assist to Another Agency):

- 10 Suspicious Person
- 3 Suspicious Activity/Incident
- 1 Suspicious Auto
- 2 Trespass
- 10 Other – usually related to criminal activity CFS
- 2 juveniles were stopped
  - Throwing rocks
  - Fireworks
- 3 M/W
- 20 M/B
- 3 F/B

In **May**, there were 18 pedestrian stops resulting in three arrests (Warrant, Criminal Trespass and Retail Theft):

- 6 Suspicious Person
- 3 Suspicious Activity/Incident
- 2 Trespass
- 7 Other – usually related to criminal activity CFS
- 4 were stopped for one incident
  - Checking vehicle doors
- 3 M/W
- 2 F/W
- 1 F/H
- 12 M/B

In **June**, there were 22 pedestrian stops in response to 19 incidents with multiple individuals stopped for one CFS:

- 9 Suspicious Person
- 8 Suspicious Activity/Incident
- 1 Suspicious Auto
- 2 Trespass
- 2 Other – usually related to criminal activity CFS
- 3 M/W
- 3 M/H
- 15 M/B
- 1 F/B
