Instructions for Non-Agenda Public Comment

It is not intended for a dialogue with the Board. Non-agenda public comment is limited to 30 minutes with a limit of three minutes per person. If non-agenda public comment exceed 30 minutes, public comment will resume after the items listed under the regular agenda are complete. See instructions above on how to provide public comment.

Comments are three minutes per person per agenda item with a maximum of three agenda items on which an individual may speak.
