

**AMENDMENT TO A PROFESSIONAL SERVICES AGREEMENT BETWEEN HR GREEN INC.
AND THE VILLAGE OF OAK PARK TO CHANGE THE NOT TO EXCEED AMOUNT FROM \$1,000,500
TO \$1,010,500 TO ALLOW FOR HEALTH PLAN REVIEWS AND HEALTH INSPECTION SERVICES**

THIS AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT (hereinafter referred to as the “Amendment”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and HR Green, Inc., an Iowa corporation authorized to conduct business in the State of Illinois (hereinafter referred to as the “Contractor”) is entered into as of the effective date set forth below (also collectively referred to as the “Parties”).

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated December 9, 2020 (“Agreement”) which was renewed on December 29, 2021 to expire on December 31, 2022 (“Renewal”); and

WHEREAS, the Parties seek to amend the Agreement to change the not to exceed amount to allow for health plan reviews and health inspection services.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** The Agreement is amended to add additional services to the Contractor’s Scope of Services as follows:

Added Services: Health plan reviews and health inspection services for non-related facilities shall be provided at the Village’s request at the hourly billing rate of \$138.00 per hour.

3. **AMENDMENT TO RENEWAL.** The Renewal is amended to add the underlined language and delete the overstricken language as follows:

WHEREAS, the parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed ~~\$1,000,500~~ \$1,010,500.

4. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

5. **EFFECTIVE DATE.** This Amendment shall be the last date of its execution by one of the Parties as reflected below.
